This agreement is made between The Pier Village Association and Art Downtown with
the exhibitor named below for the use of space at the **Annual Spring Invitational Arts & Crafts Show**
in Postell Marketplace on St. Simons Island, Georgia:

1. Exhibitor must supply all display props - including chairs, tables, etc. and all tools necessary to prepare booth(s) for display.
2. Exhibitor must represent his own display. All booths must have exhibitor's name prominently displayed.
3. Exhibits must be open for business 10:00 am to 5:00 pm both days. (DO NOT LEAVE EARLY)
4. Exhibitor agrees to accept full responsibility for the care and protection of his/her exhibit.
5. It is the responsibility of the exhibitor to have all liability insurance needed.
(The Pier Village Association nor Art Downtown accepts liability in relation to the exhibits.)
6. Only items approved by the jurying committee may be sold.
7. Space size will be 10' x 10'. Cost is \$185.00 per space and includes electricity.
8. All items displayed must be original work. No mass production displays, no kits, supplies, or imports. No flea market items.
If the Show committee determines that you are selling buy/sell merchandise, you will be asked to leave the show.
9. There is NO SMOKING in the park.
10. No refunds are given.
