Eligibility: The exhibition is open to members of FATE. Current FATE Membership is required by February 15th in order to exhibit. Please visit the FATE website for more membership information on how to join or renew your membership.

Limitations: All media are eligible. Exhibiting FATE Members are responsible for providing any installation instructions and special equipment, including any electronic equipment that the

work might require. Work must be exhibition ready. CCAD reserves the right to reject work not properly prepared for exhibition.

FATE is committed to being inclusive by encouraging participation from a diverse range of voices within underrepresented identities and communities. In addition, we encourage participation from a wide spectrum within the artistic community.

Entry Fee: A nonrefundable fee \$35 for up to 3 entries must be paid credit or debit card through the online submission entry process.

Submissions: Please apply through the **National Juried Members Exhibition Submission Form** linked on the FATE 2019 Conference website: <https://wwwFOUNDATIONS-art.org/conference>
For each entry, please provide title, dimensions, medium, date created, and price/value if not for sale. You may provide 1 image per entry (1 full view & 1 optional detail or additional view)

Sales: All work must be either priced or valued for insurance purposes. A 50% commission is charged on sales. Sale price should include commission. Work not for sale should be noted as such in the submission process.

Liability Agreement: Although every effort will be made to ensure the safety of the artwork, FATE and the Columbus College of Art & Design or the Angela Meleca Gallery assume no responsibility for damage or deterioration incurred before or after the exhibition or for possible loss in transit. Work will be insured by CCAD during the exhibition. The submission of the entry form with documentation and entry fee constitute an agreement to all conditions of the prospectus, including permission to use a reproduction of works for publicity or catalog production. No entry materials will be returned. All accepted work must remain in the custody of CCAD from March 22nd – April 6th.

Shipping: Work may be hand delivered to CCAD by UPS or common carrier at the shipping address listed below.
