

## RateSetter – Aussie Money Man New Lender Bonus terms and conditions

### 1. New Lender Bonus offer

- 1.1. This offer commences on 01/01/2019 and is available to all New Lenders who satisfy the applicable Eligibility Criteria set out below by 31/07/2019 (**Termination Date**).
- 1.2. A person who becomes a member of the RateSetter Lending Platform in accordance with the Eligibility Criteria (**New Lender**) is entitled, pursuant to clause 1.3, to receive \$100 (the **New Lender Bonus**).
- 1.3. The **New Lender Bonus** will be credited by way of an addition of funds to the New Lender's Portfolio. For this purpose, the responsible entity of the RateSetter Lending Platform will treat the participation in the New Lender Bonus offer by a New Lender as an application for an addition of funds to the member's holding account, made at the time that the New Lender Bonus is paid.
- 1.4. Where a New Lender becomes a member of the RateSetter Lending Platform in the capacity of a joint member, a trustee or a company, only one New Lender Bonus will be paid to the member under this offer.
- 1.5. The offer is not applicable in conjunction with any other promotional offer unless expressly indicated.

### 2. New Lenders

- 2.1. A New Lender is eligible to receive the New Lender Bonus upon meeting the following conditions (the '**Eligibility Criteria**') before the Termination Date:

  - 2.1.2. The New Lender is accepted as a member of the RateSetter Lending Platform; and
  - 2.1.3. The New Lender transfers \$1,000 or more into their holding account and places orders in the 3 Year Income or 5 Year Income lending markets such that at least \$1,000 is 'on loan' to borrowers within 30 days of becoming a member of the RateSetter Lending Platform.
- 2.2. If a New Lender (or any of their associates or related entities, including without limitation where the related entity is a trust for which the New Lender is a trustee or beneficiary) is or has previously been a member of the RateSetter Lending Platform, then the New Lender is not eligible for this offer.
- 2.3. A New Lender can receive at most only one New Lender Bonus under this offer.
- 2.4. The use of a false name or address when registering to become a member of the RateSetter Lending Platform will result in the Eligibility Criteria not being met and the New Lender not being eligible for the New Lender Bonus.

### 3. Other terms

- 3.1. Applications to be a member generated by a script, macro, robot or any other automated process not authorized in writing by RateSetter Australia will be void.
- 3.2. No responsibility can be accepted for applications or funds transferred lost, delayed or corrupted, or due to computer error in transit.

- 3.3. Any amounts payable to a New Lender are not transferable to another individual or member and no other alternatives will be offered.
- 3.4. RateSetter Australia reserves the right to amend or alter or cancel this offer and reject claims for the New Lender Bonus from New Lenders not entering into the spirit of the promotion.
- 3.5. RateSetter Australia reserves the right of ownership of any member-generated content submitted to the promotion and unreserved rights of reproduction in any marketing or promotional media that it sees fit.
- 3.6. Members may incur a tax liability in relation to the New Lender Bonus.
- 3.7. Any amount payable under this offer is inclusive of GST (if applicable). You will tell us if you have a liability for GST in respect of any amount payable under this offer. If you have a liability for GST, you will provide us with a tax invoice for the supply within 28 days of the payment.
- 3.8. The promotion may be modified or withdrawn at any time.
- 3.9. Where this offer is withdrawn in accordance with clause 3.4, RateSetter will honour all approved New Lender membership applications made before the offer is withdrawn, provided that New Lenders satisfy all the Eligibility Criteria.
- 3.10. The New Lender Bonus will be paid within 30 days of the relevant Eligibility Criteria being met.
- 3.11. In this offer, unless defined in this document or the context otherwise requires, terms have the same meaning as set out in the Product Disclosure Statement of the RateSetter Lending Platform.
- 3.12. This offer will be governed by and construed according to the laws in force in the state of New South Wales. Each party unconditionally and irrevocably submits to the exclusive jurisdiction of Courts with jurisdiction in New South Wales and all appellate Courts from such Courts.
