An advisory committee has been appointed by the Community Foundation of West Texas Board of Trustees to assist in the review of arts proposals. This group will make recommendations to the Foundation's Grants Committee and Board of Trustees for funding of arts activities and initiatives that they believe to be of the greatest benefit to the community. Approximately two-thirds of the grants will be awarded for the support of smaller arts organizations and one-third to larger organizations and for special initiatives.

Grantmaking policy and grant award decisions are made by the Board of Directors. Support from the Sybil B. Harrington Endowment for the Arts is restricted to organizations in Lubbock and Hale Counties that are 501(c)(3) or the government equivalent. Grants may be made for start-up funding, general operating support, program support, equipment and facilities, emergency needs and demonstration programs. The Foundation does not make grants to individuals, for political purposes, to retire indebtedness or for payment of interest or taxes. All grant recipients must report on the expenditure of grant funds and results of the supported project within one year of the award.

The Community Foundation of West Texas accepts proposals on January 15th of each year. (If the 15th happens to fall on a weekend or a holiday, proposals are accepted on the first working day following the due date). After we receive your complete proposal, copies will be provided to the Arts Advisory Committee who will review and provide comments. Additional information or a site visit may be requested. The Grants Committee will then make its recommendations to the Board of Directors. You will be notified of the Board's decision as soon as possible after the Board meeting at which your application is considered.

- Projected number to be served;
- Specific use of funds requested;
- A list of other partners in the project and their roles; and
- A timetable for implementation including major events, activities and when they will take place.

- Organization Budget - Projected and actual revenue and expense line items for current fiscal year
- Current Financial Statements - Most recent month end Statement of Financial Position and Statement of Financial Activities
- Most Recent Year End Financial Statements - Most recent Year End Statement of Financial Position and Statement of Financial Activities
- Most Recent IRS Filing (Form 990)
