### Please read the following and initial as agreement.

- \_\_\_\_\_ I understand that foster pets could be incubating an illness that is not obvious and should remain isolated for 7 days.
- \_\_\_\_\_ I understand that Bella's Promise Pet Rescue retains ownership of all foster pets in foster care, and reserves the right to reclaim and terminate foster care if the Rescue determines that it is in the best interest of the foster pet.
- \_\_\_\_\_ I understand that I must follow all care instructions given regarding the foster pets in my care, to keep the foster pet secure and indoors only, except dogs walked on a leash, and to return the foster pet to Bella's Promise Pet Rescue when requested.
- \_\_\_\_\_ I understand that all adoption and medical decisions regarding the foster pet in my care will be made by Bella's Promise Pet Rescue.
- \_\_\_\_\_ I agree to notify the Foster Coordinator immediately if I suspect any illness in a foster pet. I understand that all veterinary visits must be to veterinarians that are endorsed by Bella's Promise Pet Rescue, and veterinary and medical expenses must be approved in advance by the Foster Coordinator. I understand that such expenses not approved in advance are the sole responsibility of the foster caregiver (me). In emergency after hours, I must contact the Foster Coordinator immediately.
- \_\_\_\_\_ I agree to not give the foster to another person or to promise that their adoption of a foster pet will be approved. If it is determined that I gave my foster pet to someone without the prior written approval of Bella's Promise Pet Rescue, I agree to pay any just and reasonable amount to cover the expenses accrued by Bella's Promise in securing the safe return of a foster pet that was in my care.
- \_\_\_\_\_ I understand that although Bella's Promise Pet Rescue takes reasonable care to screen foster pets prior to placement, the Rescue makes no guarantees relating to the foster pet's health, behavior or actions. I understand that I receive foster pets at my own risk and I can refuse to foster and return the foster pet to the Rescue (providing a reasonable amount of time to secure another foster home).
- \_\_\_\_\_ I acknowledge that Bella's Promise Pet Rescue is not responsible for any property damage or personal injury or illness suffered by me, members of my household, including my pets, or third parties during a foster placement, and I assume liability to provide adequate controls to prevent such damage or injury.

I have read and understand all the statements above. I declare that the information given is true and correct, and agree that if any false information has been provided, it may nullify my foster care contract with Bella's Promise Pet Rescue and I will arrange for the return of all foster pets in my care to the Rescue.
