RESOLUTION NO. 17- 18

**A RESOLUTION DECLARING NECESSITY FOR A 1.00 MILL TAX LEVY FOR FIRE PROTECTION SERVICES OF THE VILLAGE OF NEW MADISON, OHIO PURSUANT TO OHIO REVISED CODE §5705.19(I) AND TO PROCEED WITH CERTIFICATION TO THE BOARD OF ELECTIONS**

**WHEREAS**, the Council for the Village of New Madison, Ohio, finds that the Village is in need of additional funds in order to provide fire protection services to the Village and intends to levy a new tax for the purpose of generating said funds, as authorized by § 5705.19(I) of the Ohio Revised Code; and

**WHEREAS**, the Village finds that the minimum rate authorized by the Ohio Revised Code for the taxation of property will generate inadequate funds to meet said expenses of the Village; and

**WHEREAS**, the Village wishes to levy a new 1.00 mill tax for expenses associated with fire protection services; and

**WHEREAS**, the revenues generated by said levy is necessary for the continuation of vital public services;

**NOW THEREFORE, BE IT RESOLVED**, by the Council for the Village of New Madison, Darke County, Ohio, by two-thirds of all members elected thereto concurring as follows:

**Section 1:** The amount of taxes generated by the minimum authorized by §5705.03 of the Ohio Revised Code being deemed to generate insufficient income for fire protection services, the Village shall, therefore, seek to levy a new 1.00 mill tax for fire protection services pursuant to Ohio Revised Code §5705.19(I), which shall be submitted for approval by the electorate.

**Section 2:** The proposed levy shall be used for the expenses associated with the fire protection services of the Village and otherwise as may be permissible in accordance with §5705.19(I) O.R.C.

**Section 3:** This is a new tax levy pursuant to §5705.19(I), O.R.C.; and shall remain in effect for a period of five (5) years, beginning with the 2017 duplicate year.

**Section 4:** The question of said levy shall be submitted to the electors of the Village at the general election held on November 7, 2017.

**Section 5:** Pending presentment to and approval by the electorate of the Village of New Madison at the election to be held on November 7, 2017, the levy shall be placed on the tax duplicate for a five (5) year period of time beginning with the 2017 tax duplicate year with collection starting in the year 2018 at the rate for each year of 1.00 mills on each dollar of tax valuation of the taxable property which amounts to ten (10) cents for each one hundred dollars (\$100.00) of valuation within the Village of New Madison.

**Section 6:** The Clerk shall be, and hereby is, directed to certify a copy of this Resolution, to the Darke County Auditor to attach the Auditor's Certification to this Resolution and to the Board of Elections, Darke County, Ohio, not less than
