We urge your leadership in passing legislation that will limit climate pollution, provide a path for our rural communities to transition to cleaner energy and greater energy efficiency, and help our communities prepare for the impacts of a changing climate.

Our rural communities are observing dramatic changes in the climate, which we must address or lose our livelihoods.
