1. There is no charge to ride the Morris Transit this summer. This is in part to prevent the spread of COVID-19 through transfer of money. As of right now our plan is to resume collecting fares on September 1st, 2020.
2. The hourly stops at Nature's Edge, Willie's, and UMM are canceled until further notice. If you need a ride from any of these places, give us a call!
3. Remember to call in advance in order to ensure you get a ride at the time you want. Riders calling an hour or two in advance is helpful to the drivers and allows us to more efficiently and safely schedule rides.

Mediacom is extending through our July and August billing cycles a series of previously announced initiatives to help American families. Some of the specific initiatives included are:

SCMC COVID updates

Urgent Care-Temporary changes to weekend urgent care hours. We ask that patients call 320-589-1313 prior to coming in on weekends. They will be instructed during that call on the time to come in. Patients with non Covid-19 symptoms will be seen between 9am-11am and those with Covid-19 symptoms will be seen between 11:30am-12:30pm.

Weekday Urgent Care will operate as usual. M-F 8am-5pm, with the exception of Friday, July 3rd closing at 12:30 pm.

We are not allowing visitors at this time. Patients and families should discuss special arrangements with their care team. Thank you for your understanding as we work to ensure a safe environment for our patients and our workforce. We also are limiting the number of people who accompany a patient for scheduled appointments to just one person.

We are screening everyone. You will be screened upon entering Stevens Community Medical Center. Your temperature will be taken and you will be asked if you are experiencing the following symptoms: Fever, Cough, Sore Throat, Shortness of Breath, or other Respiratory Symptoms.

A mask must be worn. We are a universal mask facility. After you are screened and approved to enter the building you will be given a mask that must be worn at all times while at Stevens Community Medical Center.

Buddies Bar and Grill is now back to our normal business hours. Kitchen open from 11 am to 10 pm. Off sale open from 10 am to 10 pm (11 am to 6 pm Sundays). Bar opens at 10 am and will close at the bartender's discretion dependent upon business after 11 pm.
