

Privacy Statement

1. Introduction

We take your privacy very seriously. This page explains what information we collect about you, how we may use it, and the steps we will take to ensure it is kept secure while using MiKimFX.

By using MiKimFX or by accessing any part of this web site, you agree to the collection and use of information in accordance with this Privacy Policy and you will be deemed to have accepted this Privacy Policy in full. By submitting your personal data to us, you will be treated as having given your permission for disclosures referred to in this policy. If you do not agree with any of these terms and conditions, please do not use this site.

International Users - By visiting our web site and providing us with data, you acknowledge and agree that due to the international dimension of the Site we may use the data collected in the course of our relationship for the purposes identified in this policy or in our other communications with you, including the transmission of information outside your resident jurisdiction. In addition, please understand that such data may be stored on servers located outside your country's jurisdiction. By providing us with your data, you consent to the transfer of such data.

2. Information we may collect

2.1 Personally Identifiable Information (PII)

By using MiKimFX, we may ask you to provide us with certain Personally Identifiable Information that can be used to contact or identify you. This includes, but is not limited to, your name, email address, phone number and postal address. This information is used for processing your orders when you are buying goods or services from us.

We do not use or disclose your personal information collected for any other purpose other than the primary purpose without firstly gaining your consent, or where it is required by law.

2.2 Device information

When you visit MiKimFX, our Internet Service Provider makes a record of your visit. The computer systems and software used by the site, acquire certain personal data in the normal course of the service, which is implicit to be able to use the Internet communications protocols.

Also, the following information is logged, used, and monitored for statistical purposes, enforcement of the Privacy Policy and to facilitate user disputes:

- IP addresses and other technical information
- Date and time of your visit
- Page views and website interaction

This data is cancelled immediately after processing and is used exclusively for anonymous statistics data relative to the use of the site and to check it is working correctly. The data could also be used to investigate responsibility in the event of computer crimes that damage the site; apart from this possibility, the data relative to the web contacts is not stored for more than thirty days.

2.3 Cookies

We use cookies store information while you visit MiKimFX. You may configure your browser to reject our cookies. However, this may lead to disruption of our service, such as unable to log in and unable to store products in your shopping cart. If you want to remove our cookies, we recommended installing a plugin that removes cookies after your visit.

We may disclose the above collected information about if required to do so by law or in the good faith belief that such disclosure is reasonably necessary to respond to subpoenas, court orders, or other legal process.

We may also disclose the above collected information to law enforcement officers or others, in the good faith belief that such disclosure is reasonably necessary to: enforce our Privacy Policy; respond to claims that any posting or other content violates the rights of third-parties; or protect our rights or of the general public.

3. Data encryption and storage

MiKimFX uses SSL encryption technology. Your communication with us is transferred exclusively as encrypted data. We use computer safeguards such as firewalls and data encryption, we enforce physical access controls to our buildings and files, and we authorize access to personal information only for those employees who require it to fulfill their job responsibilities.

We primarily store and process your personal data in the EU/European Economic Area (“EEA”). If we do transfer your personal data outside the EEA it will be because you have consented or because we have a legal reason to do so.

We will not retain your personal information for longer than required.

4. Service providers

We may share your personal information with third parties to facilitate our service. These services include, but are not limited to:

- Payment service providers
- Delivery services
- Accounting and invoicing providers

Our contracts dictate that these service providers only use your information in connection with the services they perform for us and not for their own benefit.

4.1 Links to other websites

MiKimFX may contain links to other websites which are not under our control. We do not accept any responsibility or liability for the content, privacy policy, practices and availability of third party sites. We strongly advise you to review the privacy policy of every website you visit before you submit any personal data. You are also advised to go through the website legal policies of such sites before initiating transactions through such sites. We are not responsible for the working of such sites. We do not in any manner whatsoever hold liability for any errors in payment amounts, method, technical problems in payment, etc.

5. Protection of children

We recognize the importance of protecting the privacy and safety of children. Our website, and any services available from this website, are not directed to children under the age of 13. We do not knowingly collect information about children. A parent or guardian of a child may contact us if he learns that a child under the age of 13 has provided us with their personal information, so we can take appropriate action. You agree not to assign or otherwise transfer this privacy policy in whole or in part; any attempt to do so shall be void.
