DEADLINE: WEDNESDAY DEC 4, at 5 PM

EXHIBIT: December 6, 2019 to January 8, 2020

Round Hill Studio (280 St-George St. Annapolis Royal, NS) is accepting submissions for ***Wee Art*** and encourages new artists to be part of this exciting event. This year, we are offering the opportunity to submit up to 4 works whose size and dimension are **6" wide x 6" high (6" deep for 3D)**. Hung and 3D art are welcome for consideration. All pieces will be priced at **\$75**, so please consider this when creating your pieces.

Submissions will be reviewed on an ongoing basis. If accepted, all work must be **dropped off** at the Gallery on **Wednesday, December 4** after 12 noon to no later than 5 PM. Artwork must be **picked up** between 12 PM to no later than 5 PM on January 9 2020.

Before applying please be sure to familiarize yourself with the Participating Artist Agreement which outlines the criteria for artwork and the Terms and Conditions for Artists exhibiting in ***Wee Art!***

Process:

1. Submission Form/Artist Agreement (see last page).
2. Fill out the form and email it, along with your images attached to info@roundhillstudio.com with the subject line: "Wee Art"
The submission form should be saved as WeeArt_lastname_firstname.docx or .pdf
3. Image files should be named lastname_firstname_title.jpg

Important: Please Read and Sign

1. The Gallery and the Artist agree that the Gallery's commission is to be 30 percent of the Retail Price of the Artwork. Any change in the Retail Price, or in the Gallery's commission, must be agreed to in advance by the Artist and the Gallery.
2. The Artist shall submit their art to The Gallery ready to be hung and/or displayed; this means wired securely. The Gallery will not permit any of the Artworks to be hung or displayed if the condition of the piece is not satisfactory to The Gallery.
3. The Artist hereby consigns to The Gallery, and The Gallery accepts on consignment, those Artworks listed on the attached Inventory Sheet which is a part of this Agreement.
4. The Gallery shall not be liable to the Artist for their loss or damage. The Artist shall provide insurance coverage for their Artwork.
5. Choice of Law. This Agreement shall be governed by the law of the Province of Nova Scotia.
