### GREETINGS FROM OUR NATIONAL DIRECTOR





On the first day of July, we celebrated CANADA DAY and we are 153 years old as an official country, but of course, the land occupied by indigenous peoples is much older than that. In 1867 the British North America Act (Confederation) or The Constitution Act brought into being our federal dominion and established much of the way we do business as a nation; the House of Commons, Senate, justice and taxation systems all come from this act. The Constitution Act of 1982 added amendments to the original including The Charter of Rights and Freedoms. So our country is a land rich in so many ways. I am intrigued by the original lyrics of our National Anthem written by Robert Stanley Weir in 1906. The favour I am asking of you... is to stay well and be blessed as you continue to bring light and God's loving embrace to your family and your neighbours. And if you haven't prepared for the future, now may be the time!

# **5 Step Will Planning Guide**

# Step One: Have a Plan.

You need a plan that will ensure all your loved ones are looked after as well as help you avoid/eliminate estate taxes through giving to Registered Canadian Charites. As you think about your plan, list all of the people you want to care for through your estate. You can only give to three places in your estate: relatives, the government (in estate taxes) or registered Charities. Be generous – as giving to charity is what can reduce and even eliminate estate taxes while still looking after your loved ones. Remember your church is needed now more than ever.



And the ministry of your church will continue after you are gone – and will need support. As you imagine what joy and blessing your estate gift will bring to your church as they serve and build The Kingdom, know that it also becomes a delightful fragrance to God's heart (Phil. 4:8).

# Step Two: Create a Will.

Once you have your estate plan completed, you need to add/incorporate this into your Will. You can make reference in your Will to follow the Estate Plan you created in Step One. We recommend using the services of a lawyer but there are other low cost options available:

Hand-written (Holographic) Will - Use a blank piece of paper, label this your "last will and testament" and hand-write your wishes, date and sign (no witnesses required). Must be able to prove this is in your own handwriting to be val-



id. NOTE: Holographic Wills are not legal in British Columbia.

**Download a Do-it-Yourself Will Kit** – These are good for simple estates but usually fail to cover 'what if' scenarios.

Online interactive Will service – These services will guide you through the process and are specific to your Province or Territory and will even check for errors. There is normally a small fee for the use of this service. After answering all the questions, the service compiles a document that can be downloaded and printed.

Use the services of a lawyer (or Notary in BC or Quebec) — This is recommended as the traditional approach for making a will. If you do not have a lawyer, ask your pastor to recommend one to you. And, sometimes the best way to find a lawyer is to ask your friends and family. Your Estate Plan will help guide/instruct your lawyer in writing the Will as well as reduce the amount of time spent/costs discussing this with your lawyer.

Other than the hand-written Will, all final Wills should be signed in the presence of two adult witnesses that are not beneficiaries (and in some jurisdictions, they cannot be the spouse of a beneficiary) to turn it into a legal Last Will and Testament.

# Step Three: Get Your Documents Together.

Once your Will is in place, there are other documents you should make sure are compiled:

Your Complete Estate Plan.

A document outlining your **funeral wishes** and/or funeral arrangements that have already been made including contact information.

**Inventory of Assets** (including life insurance policies, investments, properties, savings accounts, etc.) and the passwords, codes and/or contacts to access them.



**Financial Power of Attorney** to give someone authority to access to your finances and **Living Will** (Healthcare Power of Attorney / Advance Directives) to give someone authority to make decisions about your health care.

# Step Four: Keep All Documents Safe and Accessible.

All these documents should be kept in a secure place. They also need to be accessible in case something happens.

Your named executor should know where to quickly find a copy and where the originals are stored.



# Step Five: Keep it Updated.



The general rule of thumb is that your Will should be reviewed and, if needed, updated every 4-5 years or after any major life/asset change.

You can also review and update your estate plan as well.



It is never too early – nor too late! - to create a Will.

Due to a hip problem, he retired from full-time ministry after over 40 years, continuing to do evangelism, interim and visitation pastoring until he was 81. Upon moving into a retirement home in Calgary, he again felt called to start a Bible study which he supported until he was 98 years old.

Howard & Ruth donated significantly to the Village of Hope in Bangladesh.

If Howard said he would pray for you - he did!! He was up early every morning so he could have this quiet time alone with his Heavenly Father! He continues to use his phone and his computer as visitation tools to many of the people he has known & prayed for over the years.

Ruth passed away April 2019 after a long hard-fought battle mentally & physically. He misses her so much. Howard & Ruth had 2 daughters. Howard is a member at Calgary First and misses being able to attend on a regular basis.

# Engagement with the Black Strategic Readiness Team BOARD OF GENERAL SUPERINTENDENTS CHURCH OF THE NAZARENE

The Black Strategic Readiness Team (BSRT) was established by the 1968 General Assembly (then named the "Black Council") as a resource to help develop strong Black leadership and to guide the church regarding issues of race. Throughout the intervening years, they have worked tirelessly for the Black Church of the Nazarene in the United States. The names and faces of the Council have changed, but today, the members are second and third generation Nazarenes who have a deep love and commitment to the message of scriptural holiness and the Church of the Nazarene.

Organized by the BSRT and supported by the USA/Canada Region, a National Black Nazarene Conference meets bi-annually and celebrates the life and work of the numerous Black Churches of the Nazarene in the United States and Canada. Desiring to enhance the commitment of the denomination to Black Nazarenes and their communities, the Board of General Superintendents has been specifically engaged for the last 18 months in strategic planning and prayer with the BSRT. Additional funding has been provided to Black ministries to help foster real and lasting change for the future of the church.

Addressing systemic issues of injustice is not a comfortable exercise because it requires us to reflect upon ways we may have contributed to the problem. The current conversations around racism in the United States, and around the world, call us to a time of self-examination.

The Church of the Nazarene has made clear our statement on discrimination in Manual 915. The highest governing body of the Church of the Nazarene, the General Assembly, added the following paragraphs to the statement during its most recent meeting in 2017:

Therefore, we renounce any form of racial and ethnic indifference, exclusion, subjugation, or oppression as a grave sin against God and our fellow human beings. We lament the legacy of every form of racism throughout the world, and we seek to confront that legacy through repentance, reconciliation, and biblical justice. We seek to repent of every behavior in which we have been overtly or covertly complicit with the sin of racism, both past and present; and in confession and lament we seek forgiveness and reconciliation.

Further, we acknowledge that there is no reconciliation apart from human struggle to stand against and to overcome all personal, institutional, and structural prejudice responsible for racial and ethnic humiliation and oppression. We call upon Nazarenes everywhere to identify and seek to remove acts and structures of prejudice, to facilitate occasions for seeking forgiveness and reconciliation, and to take action toward empowering those who have been marginalized.

This is a powerful statement that calls the church to action. The biblical message of holiness challenges us not only to examine our hearts but to assume corporate responsibility to speak against and proactively reject any systems or structures that oppress our brothers and sisters in Christ, including those that may exist in the church.

In light of recent events in the USA and other parts of the world, the BSRT is renewing its mandate to help guide the church to take actions that will strengthen our fellowship and witness. The BGS joins with the BSRT in this prophetic call to action. Click here for the action steps recommended by the BSRT. May God help us to live out the message of holiness, individually and corporately, reflecting on where we have come, and with holy boldness be filled with the Spirit's power to embrace God's vision for reconciliation and healing in the world.

# STATEMENT ON THE 30TH GENERAL ASSEMBLY BOARD OF GENERAL SUPERINTENDENTS CHURCH OF THE NAZARENE

The world has been impacted by an unexpected pandemic that has affected every area of life, including the health, safety, finances, and mobility of the global church. As a result, the Board of General Superintendents (BGS) has called for several entities to review plans for the upcoming 30th General Assembly and Conventions, scheduled for 23 June -2 July 2021 in Indianapolis, Indiana, USA. This review has considered the purpose of the General Assembly, the options available to achieve the purpose, and the implications of convening the General Assembly on the scheduled dates.

#### **Purpose of the General Assembly**

The Manual of the Church of the Nazarene serves as a guide when it comes to understanding the full purpose of the General Assembly. As a uniquely global body, the General Assembly is one of the primary, visible reflections of the unity in the Church of the Nazarene (Manual, "Preamble to Church Government," p. 64). In addition, "the General Assembly is the supreme doctrine-formulating, lawmaking, and elective authority of the Church of the Nazarene," (Manual, p. 300). Therefore, the purpose of the General Assembly is both constitutional (legislation, election, and doctrine-formulation) and connectional (an expression of the global unity and diversity of the denomination).

#### **Current considerations**

The COVID-19 pandemic has touched the global church in many ways. As the virus
spreads around the world,
Global travel has either been restricted or deemed unsafe.
☐ Embassies and consulates have closed, and the dates for reopening remain uncertain.
☐ Access to visas to travel to the United States and through transit points have been de-
layed.
☐ Financial challenges at the local church level have impacted the districts' ability to budg
et for the upcoming General Assembly.

As the BGS has consulted with a variety of professional and ecclesial advisors, most agree that the current conditions will continue for an extended period of time, recognizing it is difficult to forecast when the pandemic's impact will slow.

Based on these considerations and realities, the BGS has determined that the current conditions do not allow the denomination to fulfill the purposes for which the General Assembly has been designed. The health risks, restricted mobility, and lack of financial resources all combine to create limitations for a truly global representation to attend the General Assembly as scheduled in 2021

In harmony with the provision in Manual 302.1, the BGS met with the Executive Committee of the General Board to review the possibility of holding an electronic, remote General Assembly in simultaneous locations around the world. At the 10 June 2020 meeting of the Executive Committee of the General Board, it was unanimously decided that "a multi-site electronic assembly would not allow us to fulfill the essential purposes of the General Assembly as stated in the Manual."

Based on these realities, the Executive Committee of the General Board, acting on behalf of the General Board, unanimously recommended that the General Assembly Commission "consider postponing the 30th General Assembly to a time when the conditions may guarantee the safe participation of a large global contingent."

#### **DECLARATION**

After studying the current impact of COVID-19 globally, including the likelihood of conditions being appropriate for scheduling the 30th General Assembly in a way that includes both significant global participation via attendance and an appropriate emphasis on the health and safety of visitors and delegates, the General Assembly Commission, acting with the authority vested by Manual paragraph 302, has taken the following action:

- 1. To declare a state of emergency that prevents the implementation of the 30th General Assembly as scheduled in Indianapolis, Indiana, USA, in 2021.
- 2. To postpone the meeting of the 30th General Assembly to 2023 given the fact that there is no assurance of global mobility and global economic recovery for at least two years.
- 3. To work as a General Assembly Commission on determining the actual dates and location for the 30th General Assembly in 2023 as sites become available.

#### A WORD FROM THE BOARD OF GENERAL SUPERINTENDENTS

This has been a very difficult yet crucial decision. When we began meeting with various constituencies to review the realities brought upon us by this global crisis, we soon realized that there were no ideal options for us. We firmly believe that it is essential for the global family to gather together, not only to fulfill our constitutional mandate to formulate doctrine and polity but especially to reflect the richness of our unity expressed by the beautiful diversity of our global family. And yet, we take seriously the necessity to protect those attending, as well as the representative nature of our denomination by ensuring that everyone will be given equal opportunity to attend a gathering of this magnitude.

This has been a complicated decision. While we would have loved to postpone the assembly for only one year, we could not gain assurance of higher participation from our brothers and sisters from those global communities that have been affected by the pandemic due to either limited healthcare, financial means, or the capacity to travel. Though we are grieved by the extended postponement, we support the decision of the General Assembly Commission to allow for adequate time to safeguard lives and save financial resources.

Let us continue praying for the Lord to guide and keep the church and to provide what is needed for all of us to gather together soon, at the appointed time.

These are unprecedented times, but any uncertainty regarding the future is fortified by the promise: "Blessed are those whose strength is in the LORD, whose hearts are set on pilgrimage...They go from strength to strength till each appears before God in Zion" (Psalm 84:5, 7).

#### FACE MASKS FOR FALL

Ambrose University invites you to help us provide each student with five face masks this fall. Our target is 3000 masks by August 15, 2020.

It is important that anyone involved with the creation of homemade masks be free of COVID -19 symptoms and should not have been recently exposed to anyone experiencing symptoms.

Masks can be made from any template. There are many examples on the internet. We are in need of standard adult face masks - with two layers. Please keep in mind when selecting the materials that masks should not be too heavy or hot for the wearer.

Typically, a mask requires the following materials:
$\square$ 100% cotton or muslin fabric for outer layer – Clean cotton bedsheets can be used as long
as they are clean, unstained and breathable
• Don't use flannel
☐ elastic or twill tape or cotton material for ties
☐ Sewing machine
☐ Light-colored thread
□ A mask pattern
