



The two day juried Boll Weevil Art Festival 2019 will be hosted in beautiful Downtown Enterprise on Sept. 14-15, 2019 by DEBA—the Downtown Enterprise Business Association to showcase visual and performance artists in the Wiregrass area. We will transform Downtown Enterprise into an entertainment district to create a Downtown Festival featuring selected artisans, student artists, market and food vendors and live performances for the whole family.

ELIGIBILITY AND STANDARDS

- All Artists 16 years of ages and older may apply.
- Student Artists 15 and younger may participate if sponsored by a qualified instructor. Instructor should submit all student Artists collectively from the represented group.
- All Work must be original and created by the artist. Commercially manufactured items or items produced from commercial kits or molds may not be exhibited.
- Artist collaboration may qualify if the team produces a single product in one medium and explains the arrangement on the application. (Otherwise each member will be considered an individual artist and must pay individual participation fees)
- Indicate on your application if any of your artwork depicts nudity or violence. This will not affect your eligibility, but will help DEBA properly place your exhibit on the site and display advisories in keeping with the family-friendly atmosphere.
- Artists must be present and show their work throughout the entire event.

HOW TO APPLY

- Complete the attached application. Application can be scanned and E-mailed OR sent by mail to the address below.
- E-Mail or Print three high resolution jpg. Images of the work that represents the pieces to be sold during the Art Festival to AllAboutArtStudio@gmail.com. Be sure to reference your NAME and BOLL WEEVIL ART FESTIVAL in the subject line.
- Attach an artist Statement/Biography of 200 words or less. Type or print in paragraph form on 8 1/2" x 11" white sheet of paper. If possible, include a copy in the E-mail in a Microsoft Word compatible document. Describe your technique, materials, and the processes used to create your artwork. This information may be published on the DEBA website and may be edited before publication.
- **Attach current City of Enterprise Business License.**

FEES AND DEADLINES

- All Applications must include a check made payable to DEBA.
- There is a \$100 Exhibitor Fee for one artist space (12 x 12) to participate in the two day 2019 Boll Weevil Art Festival.
 - **DEADLINE** for Application Submission: August 31, 2019
Artists whose applications are postmarked OR Emailed after August 31, 2019 will be considered only if space is available.

ACCEPTANCE

- Artists will be notified of acceptance status by EMail or by Phone within 10 days of receipt of application and/or no later than Sept. 2, 2019.

EXHIBIT SPACES

- Limit one artist per space. For artist collaborations, only one space is provided. Additional 12 x 12 spaces available for \$50 each. The Boll Weevil Artists Exhibits will be located on the Green Space behind the 100 block of North Main Street and overnight security will be provided for this area.
- Each artist must supply his or her own 10'x10' tent, display fixtures, tables(s) and lighting if needed. Electricity will be provided as available.
- As required by law, each artist is responsible for collecting and turning in state, county and city taxes at the beginning of the Event Sept. 14, 2019. **A current business license is required for all vendors, with the exception of verified non-profit organizations. A one-day license can be obtained from the City of Enterprise for \$25 or a year long license for \$50.** Licenses should be in hand **PRIOR** to applying to exhibit. For City license and tax questions call 334-347-1211.
- Exhibiting Artisans will be notified of their exhibit location via email on September 10th. Load in for Artists will begin at 9 am on Saturday September 14, 2019.
