



**CAMP GLADIATOR, INC. AUTHORIZATION TO PARTICIPATE, WAIVER AND
RELEASE REQUIRED BEFORE MINOR MAY PARTICIPATE**

Camp Gladiator, Inc. (hereinafter "trainer") and the undersigned Minor's Parent or Legal Guardian (hereinafter "Minor's Parent or Legal Guardian") desire to outline their agreement for fitness training by Camp Gladiator, Inc. and hereby enter this agreement to confirm that **Minor's Parent or Legal Guardian waives and releases any and all claims for fitness injuries or other injuries, if any, related to fitness training by Trainer and use of equipment owned by Trainer.**

The undersigned person is the Legal Parent or Legal Guardian of the Minor listed below, and hereby gives authorization and permission for the undersigned Minor to participate in Camp Gladiator, and agrees to complete the medical insurance information.

Minor's Parent or Legal Guardian hereby warrants and represents affirmatively that the minor child listed below is in good physical condition and able to participate in vigorous exercise, including fitness training. Minor's Parent or Legal Guardian understands and recognizes that exercise and physical activities involved in fitness training may result in serious bodily injury and/or illness or even death, and Minor's Parent or Legal Guardian assumes all risk of fitness injuries involved in participating in fitness training. Minor's Parent or Legal guardian hereby warrants and represents that he or she has consulted a physician who has given permission for Minor to participate in this activity.

Minor's Parent or Legal Guardian hereby voluntarily and with full knowledge, waive, release and forever discharge Camp Gladiator, Inc., its agents, and the owner/lessor of the premises for any and all damages, of any type, or fitness injuries or other injuries known or unknown, now or in the future which Minor may suffer from participation in the training program, and from use of the premises or equipment involved in fitness training as well. This waiver and release is binding upon the Minor, and binds the party's heirs, executors, successors, assigns, administrators, and representatives.

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas and will bind all heirs, estate, successors and assigns. If any part of this Agreement is determined to be invalid or unenforceable, the remaining provisions will remain in full force and effect. This Agreement constitutes the entire understanding and agreement of the parties hereto. This Agreement can be modified or revoked only by the express written consent of the parties hereto.
