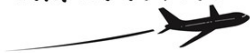

Saturday, June 13 (Dinner)

Fly to **Portland**, the “City of Roses,” and check into the Pearl District’s modern **Hampton Inn & Suites** for two nights. Enjoy the fresh cuisine of the Pacific Northwest at dinner this evening at **Jake’s Grill**.

Sunday, June 14 (Breakfast, Lunch)

Today is filled with incredible sightseeing as we travel along the picturesque **Mt. Hood Scenic Byway** into the **Cascade Mountain Range**. We will make several photo stops as we journey to one of the “Great Lodges of the West,” **Timberline Lodge**, situated within **Mount Hood National Forest**. Upon arrival we will take a **guided tour of the lodge** followed by a delicious lunch. This afternoon we will experience even more beautiful scenery as we drive along the historic **Columbia River Highway**. See the impressive **Columbia River Gorge**, which cuts the only sea-level route through the **Cascade Mountain Range**. We’ll stop at **Bonneville Dam**, **Crown Point State Park** and 620-foot **Multnomah Falls** for inspiring views. Late this afternoon we will return to our hotel for a relaxing evening.

Monday, June 15 (Breakfast, Dinner)

We begin our day with a **sightseeing tour of Portland**. You’ll soon understand why Portland has been recognized as North America’s “Best Big City.” Our tour includes a visit to one of Portland’s most prominent landmarks, the **Rose Test Garden**, where you will enjoy the sight and scent of more than 8,000 rose bushes!

Next we will head for Oregon’s dramatic **Pacific coast** where we will visit the charming town of **Cannon Beach**, named one of “The 100 Best Art Towns in America” by author John Villani and “One of the World’s 100 Most Beautiful Places” in National Geographic’s June 2013 issue! Enjoy some time to explore Cannon Beach before we travel southward along famous **Highway 101**. Our afternoon will be filled with breathtaking vistas of the crashing Pacific surf as we travel to the quaint coastal town of **Newport** where we’ll check into the delightful **Elizabeth Suites** for one night. Get settled in your comfortably appointed room complete with a private balcony and sweeping views of the Pacific Ocean. A delicious buffet dinner is included at Newport’s **Clearwater Restaurant** followed by a fun **surprise** on the beach!

Tuesday, June 16 (Breakfast, Dinner)

This morning we’ll visit the fascinating **Oregon Coast Aquarium**. You’ll be amazed at the diversity and uniqueness



of the sea life that can be found close to the Oregon shore. Have lunch at Newport's celebrated **Bay Front** before we continue to travel south along **Highway 101**. Watch for whales as you relax and enjoy the magnificent Pacific. We'll make a photo stop so you can capture one of the most notable lighthouses on the Pacific Coast, the **Heceta Head Light**, followed by a stop at **Harbor Vista Park** in the seaside town of **Florence**. We then travel inland to **Eugene** where we will check into the **Holiday Inn Express** for one night. Dinner is included at the **Oregon Electric Station**, Eugene's premier dining experience.

Wednesday, June 17 (Breakfast, Lunch, Dinner)

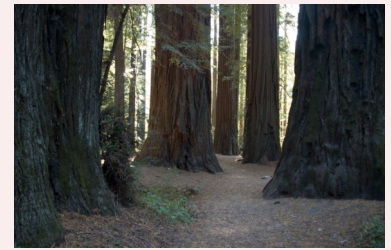
Today we will travel back into the **Cascade Mountain Range** as we drive along the **Umpqua Scenic Byway** (Hwy 138). This amazing mountain road follows the path of the turbulent North Umpqua River along which we will see several rushing waterfalls. Later this morning we will arrive at **Crater Lake National Park**, one of our country's crown jewels. No place else on earth combines a deep pure lake, vibrantly blue in color; sheer surrounding cliffs, almost 2,000 feet high; a picture perfect island; and a violent volcanic past. We will make several photo stops as we drive along the rim of the lake en route to lunch at the **Annie Creek Restaurant**. After lunch we will visit the historic **Crater Lake Lodge** and the **Steel Information Center** to learn about this fascinating natural phenomenon before we depart from the park. This evening we will check into our Rogue River-view rooms at the **Riverside Inn** in **Grants Pass** for one night. Dinner is included at the **River's Edge Restaurant**.

Thursday, June 18 (Breakfast, Lunch, Dinner)

This morning we bid a fond farewell to Oregon as our journey takes us into northern **California**, our destination – **Redwood National and State Parks**. Most people know Redwood as home to the tallest trees on Earth. But the park also protects vast prairies, oak woodlands, wild riverways, and nearly 40 miles of pristine coastline, all supporting a rich mosaic of wildlife diversity and cultural traditions. Our first stop will be the **Hiouchi Information Center** where interesting exhibits and an informative short film will provide an excellent introduction to the park. Next we will stop for lunch at the **Forest Café** followed by a visit to the **Trees of Mystery**, a privately-owned attraction nestled in the heart of the Redwoods. You will feel the same awe and wonder that Native Americans felt hundreds of years ago as you walk along the various trails. Ride the **Sky Trail gondolas** which offer a unique downward perspective of redwood trees that measure 100s of feet in height. You'll also get a spectacular view of the ocean from the observation deck located at the gondola's summit. As we continue our southward trek, we will arrive at the **Avenue of the Giants**, the world-famous scenic drive that offers the most outstanding display of giant, old-growth redwood trees in California. This evening we enjoy dinner at the charming **Benbow Historic Inn** before we check into the **Best Western Plus Humboldt House** in **Garberville**.

Friday, June 19 (Breakfast, Lunch)

Today we travel to the exquisitely beautiful **Napa Valley Wine Country** where we will visit the **V. Sattui Winery**, a picturesque and popular, family-owned vineyard and winery. We'll begin with a delicious gourmet picnic lunch (complete with wine, of course) under massive oak trees directly adjacent to the vineyards. After lunch we'll take a **tour of the vineyard and winery** followed by a fun **wine tasting session**. There will also be time to explore their great store filled with goodies and gifts to take home. Later this afternoon we will arrive in **San Francisco** – the "City by the Bay" -



where we will check into the **Holiday Inn Express on Fisherman's Wharf** for one night. The evening is free for you to explore San Francisco. Our hotel is located within easy walking distance of Fisherman's Wharf, Ghirardelli Square, the Cannery and more!

Saturday, June 20 (Breakfast)

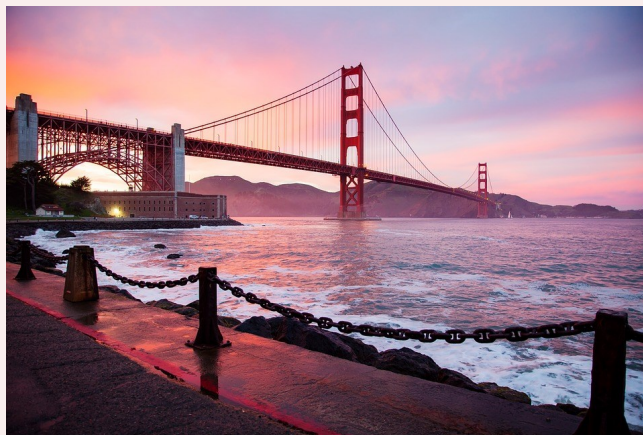
This morning we will be joined by a knowledgeable local guide for a wonderful **tour of San Francisco**. During our colorful driving tour you will see such highlights as the Golden Gate Bridge Pavilion, Presidio, Chinatown, Lombard Street, Union Square, the famous "Painted Ladies" and much more. After our tour we will stop at festive **Pier 39** (time permitting) for lunch and shopping. Here you will find over 100 specialty shops and restaurants in a waterfront setting. Now would be a terrific time to treat yourself to yummy clam chowder served in a sourdough bread bowl! Then we're on our way to the airport filled with wonderful memories of our outstanding trip to Oregon and northern California!
