Hostile Environment



- What is meant by 'illegal immigrant'?
- Why might people end up with irregular status:
- Lack of legal representation/poor legal representation
- Delays in the processing of their immigration application
- Mental health/trauma issues, e.g. survivors of torture or trafficking
- Very expensive Home Office fees
- Loss of documents; e.g. the 62 people whose documents were lost by the Home Office and were wrongly deported
- Makes it impossible for people without documents to live a 'normal' life, for example, rent a house, find work, drive, etc.
- It turns everyday people in our community into 'border guards impacts BAME people more widely due to racism, e.g. Right to Rent, Health Checks

Hostility towards migrants is not something new, though...

For these dangerous and divisive elements the legislation proposed in the Race Relations Bill is the very pabulum they need to flourish. Here is the means of showing that the immigrant communities can organise to consolidate their members, to agitate and campaign against their fellow citizens, and to overawe and dominate the rest with the legal weapons which the ignorant and the ill-informed have provided. As I look ahead, I am filled with foreboding; like the Roman, I seem to see "the River Tiber foaming with much blood."
