

## **The Valley Plaza “Get Plastic Bags Free Ready” Promotion**

### **TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.

### **ELIGIBILITY**

2. Entry is only open to Australian residents aged 16 years or over.
3. The directors, management and employees (and their immediate families) of the Promoter, printers, suppliers, providers and agencies whom are directly associated with the conduct of this promotion, and the directors, management and employees of retail tenants are ineligible to enter the promotion.
