WHEREAS, the NHDP has six members on the Democratic National Committee; and

WHEREAS, of the six DNC members from NH, DNC member – former NHDP Chair Kathy Sullivan currently serves on the DNC's Rules and Bylaws Committee; and

WHEREAS, Clark, Sullivan and Buckley have a total of sixteen years of experience on the DNC RBC providing the NHDP with great knowledge and influence on the nominating process; and

WHEREAS, the six NH DNC members have fifty-six years of combined experience on the DNC providing our delegation with the ability for great accomplishments; and

THEREFORE, we urge New Hampshire's Democratic National Committee members to vote in favor of eliminating the vote of unpledged automatic delegates on the first ballot; and

THEREFORE BE IT RESOLVED THAT, we encourage all NH members of the DNC to use their influence with their colleagues to address the many concerns that have been expressed regarding Unpledged Automatic Delegates and successfully work to reform the delegate selection process in a manner that respects both NH Primary voters and our leadership in time for the 2020 First in the Nation Presidential Primary.
