Royal Commission into Aged Care

Most probably you have heard that the Australian Government has set up a Royal Commission into Safety and Quality in Aged Care.

This is a huge step forward, after years of criticism and community concern, and a lot of media coverage of the inadequate current system.

Now underway, the Commission must submit an interim report by October 31, with its final report and recommendations due by April 30 next year.

More than 5000 individual people and organisations made submissions on terms of reference, which shows you how widespread are the concerns about the aged care system in our Australian communities.

As a result, the Commission's role is broad, and covers these vital issues:

- aged care quality, the important needs currently not being met, & extent of sub-standard care
- how best to deliver aged care services to people with dementia and/or disabilities, including young people
- the future challenges in ensuring home care services (in regional communities too) that are accessible, affordable and high quality
- what the Australian government, aged care industry, families and the wider community can do
 to strengthen a high quality and safe system of aged care service
- how to ensure person-centered services, that allow for choice, control and independence of those receiving services, and assist and encourage the involvement of families and their carers
- how to sustain the system with innovative models of care, technology, workforce and capital investments

We encourage you to make a submission to the Royal Commission, especially if you would like to see a future where there is:

- adequate government funding for good quality home care services, so that staying in your home as you age is a realistic choice for you
- high standard residential facilities for those who have greater care needs
