

## **A #SolidarityIs Guide to Hatred and Bigotry Targeting Muslim, Arab, Sikh and South Asian Communities in America**

In the decade and a half since the terrorist attacks of September 11, 2001, Muslim, Arab, Sikh and South Asian communities in America have experienced hate violence, workplace bias, vandalism at places of worship, school bullying, airport profiling, state surveillance, heightened immigration enforcement and discriminatory national security policies. The 2016 election and its aftermath exacerbated this hostile environment even further. Hate incidents targeting Muslim, Arab, Sikh and South Asian communities are among the [over 1,000 reports documented by the Southern Poverty Law Center](#) in just the few weeks after the election. In addition, advocates and organizers are deeply concerned about government policies and practices that could lead to increased targeting, surveillance, and profiling of community members.

In the spirit of the upcoming commemoration of Martin Luther King Jr.'s life, the #SolidarityIs campaign offers the following five ideas to lift up and support Muslim, Arab, Sikh and South Asian communities. While these suggestions are tailored towards organizations, faith-based groups, and networks, we encourage individuals to adapt and utilize them, especially during the [#ReclaimMLK week of action](#), organized by the Movement for Black Lives, and beyond. The ideas below draw upon the #SolidarityIs framework found [here](#), and are based on the work and guidance of members of the #SolidarityIs [cohort](#) who work closely with Muslim, Arab, Sikh and South Asian communities.

### **The 5 Step Guide**

- 1. SPREAD Awareness among members and constituencies of climate of MASA communities**
- 2. SEND Statements of Support and Affirmation**
- 3. SPUR Public Officials to Pass Resolutions and Policies**
- 4. SPONSOR and hold conversations and forums that center MASA communities**
- 5. SUPPORT community-based organizations**

## 1. Spread Awareness among members and constituencies of climate of MASA communities

### *Learning the issues:*

- [South Asian Americans Leading Together](#) (SAALT) provides [campus trainings](#), [resources on racial justice](#), and [factsheets about South Asians](#). They also released [a community guide on hate crimes](#).
- [National Network for Arab American Communities](#) (NNAAC) releases [issue briefs](#) on anti-Muslim bias, NSEERS, Racial Profiling and Protection of Civil Liberties.

- The [Arab American Institute](#) maintains [issue briefs](#) on topics ranging from immigration to hate crimes and discrimination to CVE, NSEERS, anti-sharia bills, and the anti-refugee backlash.

### *Allyship:*

- Jews Against Islamophobia in NYC and the Network Against Islamophobia, a project of [Jewish Voice for Peace](#), initiated [Chanukah Actions](#) to call the Jewish community to stand strong against anti-Muslim bias and racism.
- Supporting the [Movement for Black Lives](#) platform is a pledge to lift up all our communities.

### *For Educators:*

- [The Sikh Coalition](#) has an extensive [resource list](#) for addressing school bullying and their website [www.khalsakids.org](http://www.khalsakids.org) is devoted to toolkits for school age children.
- Educators provide resources for teachers and school administrators, including a 6-step plan for [Combating Anti-Muslim Sentiment in Schools](#) and an article on [Brown Bodies and Xenophobic Bullying in US Schools: Critical Analysis and Strategies for Action](#) which offers strategies to take action like transforming bullying behaviors directed at South Asian American youth and frameworks for understanding xenophobic and bias-based bullying.
- [Teaching Tolerance](#) develops [curriculums and workshops](#) available for educators to use in their classrooms.

## 2. Send Statements of Support and Affirmation

At this moment, your organization can make a statement that directly centers and addresses the climate facing MASA communities. Your statement could also identify resources and ways for your constituencies and members to be involved, as well as point them to community-based organizations that they can support through volunteer and financial assistance. Below are some examples and models:

- Check out these statements from [National Asian American, Native Hawaiian and Pacific Islander organizations against bigotry](#) and [this statement](#) from Asian and Pacific Islander organizations in Washington State.
- Jews for Racial and Economic Justice (JFREJ) [condemned anti-Muslim bias](#) from the NYC Council and released a [statement of solidarity](#) in the aftermath of the Pulse shooting.
- Jewish Voice for Peace [reaffirmed their commitment](#) to support MASA communities impacted by and organizing against anti-Muslim bias, white supremacy, and anti-Arab racism.
- Over 900 Asian American Scholars wrote a [statement](#) rejecting the use of Japanese American mass imprisonment as justification for targeting Muslim people.

## 3. Spur Public Officials to Pass Resolutions and Policies

Urge public officials at every level – from a city council to a school board to a governor to a college president – to take action to pass resolutions and policies that protect, defend and support MASA and all communities from hate violence and profiling.

- See sample resolutions from the [#TakeOnHate Campaign](#), [Montgomery County Council \(MD\)](#), and the [City of Seattle](#).
- [Local Progress](#) launches the [American Leaders Against Hate and Anti-Muslim Bigotry Campaign](#) and pens [open letter rejecting hate and anti-Muslim bigotry](#) with over 500 elected officials signing on.
- Encourage elected officials to make a [commitment to oppose bigotry](#) by signing a petition as part of a #NoBigotry campaign. Arab American Institute (AAI) publishes occasional reports entitled [Leadership or Pandering](#) that examine statements made by policymakers and candidates as they address divisive issues that provide clear opportunities to stand against bigotry.

Advocate with a city, a school district or campus to establish sanctuary cities and hate-free zones, where undocumented individuals will not be targeted for immigration enforcement.

- The Los Angeles Unified School District passed a [resolution](#) declaring they would not participate in any federal roundup of undocumented students and families. Read more [here](#).
- San Francisco Unified School District declared themselves a [sanctuary school district](#).

- Many colleges and universities have declared themselves sanctuary campuses including [Columbia University](#), [Wesleyan University](#), [Portland State University](#), [Oregon State University](#), [Reed College](#), and [California State University](#) (all 23 campuses).
- The [National Education Association](#) developed a [template school resolution](#) and policy and proposes [language and guidance](#) on [designating safe zones](#) and protecting students.

#### 4. Sponsor and hold conversations and forums that center MASA communities

##### *Race and Identity:*

- [Muslim Anti Racism Collective](#) and [#TakeOnHate](#) hosted a [Race & Identity Series](#) exploring the development of racialized communities—with a focus on Black, Arab and South Asian Americans—to uncover themes of racial formation, internalized racism and intercultural conflict.
- Hold and attend teach-ins on [anti-Islamophobia](#) work and resisting [Muslim registries](#). Invite activists and professors to facilitate and set the context. Contact the DC Muslims for Justice Coalition, housed with the [Washington Peace Center](#) for information.
- Hold community discussions utilizing the South Asian American Digital Archive, which lists [documentaries](#) centering South Asian American experiences or reading [articles, books, and movies](#) organized by the Movement to End Racism and Islamophobia

##### *Impact on families and children:*

- [Muslim Advocates](#) is a legal organization that published the report *Losing Liberty: The State of Freedom 10 Years After the Patriot Act*. This report could be paired with a viewing of [Whose Children Are These?](#), a documentary directed by filmmaker Theresa Thanjan about the impact of the special registration program on families and children. Issues center on national security and immigration policies that have affected communities since 9/11.
- SAALT developed [In the Face of Xenophobia: Lessons to address bullying of South Asian American youth](#) by Dr. Monisha Bajaj, Dr. Ameena Ghaffar-Kucher, and Karishma Desai, a toolkit providing lessons/workshops on different themes.

## **5. Support Community-Based Organizations by volunteering your services and/or donating funds.**
