



ORDER RESETTING TRIAL DEADLINES

Upon Motion from the State and no objection from the Defendant, the Final Pretrial Conference of October 4, 2018 and the Trial date of October 22, 2018 are hereby vacated, and

IT IS HEREBY ORDERED that:

1. On or before **Friday, January 4, 2019**, the parties shall exchange their lists of exhibits premarked for identification/introduction at trial. On or before **January 11, 2019** the parties shall file and serve a statement concerning the other party's proposed exhibits specifying which exhibits are stipulated and which are not. The bases of objections to each nonstipulated exhibit shall be set forth.
2. On or before **Friday, January 4, 2019**, each party shall file and serve a trial brief. Trial briefs shall not exceed ten pages in length. Trial briefs may include, but are not necessarily limited to: a) a brief statement of the pertinent facts; b) a statement of the legal theories and c) an identification and briefing, with appropriate citation to authority, of significant evidentiary and procedural issues of dispute or significance at trial.
3. The Court will prepare a set of stock preliminary jury instructions for trial.
4. On or before **Friday, January 4, 2019**, the parties shall file and serve their

proposed jury instructions, not including the Court's preliminary stock instructions 1-8. All jury instruction filings shall include one clean set (with no citation to source authority) of instructions submitted and one additional set of instructions with citation to source legal authority. A copy of all proposed jury instructions shall be submitted via email to rdayton@mt.gov in the form of a Microsoft Word document with size 14 Times New Roman font.


5. On or before **Friday, January 11, 2019**, the parties shall file and serve a statement concerning the other party's proposed jury instructions specifying which instructions are stipulated and which are not. The bases of the objections to each nonstipulated jury instructions shall be set forth including appropriate citation to legal authority.

6. A Final Pre-Trial Conference will be held by the Court on **Thursday, January 17, 2019, at 10:00 a.m.** at the Granite County Courthouse in Philipsburg, Montana.

7. The Trial will commence before the Court, sitting with a twelve (12) person jury, on **Monday, January 28, 2019 at 9:30 a.m., second setting** in the Courtroom at the Granite County Courthouse in Philipsburg, Montana.

8. The Court hereby reminds counsel of this Court's standing order regarding notifying the Clerk of Court at least fourteen (14) days prior to trial that a jury needs to be called.
