

## NRL at Adelaide Oval, tickets giveaway – Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of South Australia.
4. The competition is being run by PickStar, 3/25 Leigh St, Adelaide, South Australia (“PickStar”).
5. The NRL at Adelaide Oval tickets giveaway (“the competition”) commences at 5pm Australian Central Standard Time (ACST) on 5 June 2017.
6. The closing time for entering the competition is 9am ACST on 19 June 2017.
7. To enter the competition, the entrant must:
  - (a) Complete an online form and provide contact details
  - (b) fill in the feedback survey sent to attendees registered email address and submit the survey before the closing time.
8. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
9. Entrants may only enter the competition once.
10. Staff employed by PickStar and their immediate family members are not eligible to enter the competition.
11. There will be one (1) prize. This prize will be a double pass (two tickets) to NRL match Sydney Roosters v Melbourne Storm at Adelaide Oval, 24 June 2017.
12. There will be one (1) draw at 10am Australian Central Standard Time on 19 June 2017 at 3/25 Leigh St, Adelaide. The draw will be by random barrel draw from all eligible entries received with the first entry drawn being the prize winner.
13. The prize winner will be contacted within seven 8 hours of the draw by the email address supplied by the entrant on the event registration form.
14. If the prize winner does not respond to claim the prize within 48 hours of the draw, a re-draw will be conducted within 48 hours of the original draw date, in the same location, and with the same method. Redraws will continue in the same manner until all prizes have been claimed by prize winners.
15. If the prize winner is under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
