This regulation outlines the policies and procedures for operating Waller County Aviation Experience aircraft under the Board committee approval to represent WCAM as the Rutan Aircraft Flying Experience. (RAFE) aircraft.

2. APPLICABILITY:

This regulation applies to all RAFE members involved in the operation of RAFE aircraft and aircraft on loan or lease.

Chapter 1

A. Flight Operations Policies

1. Accidents/Incidents - All incidents and accidents must be reported immediately:

The Federal Aviation Administration Regulations apply at all times while flying RAFE aircraft.

Deviations are only authorized by exemption or emergency situations.

- **2. Additional Crew members (ACM)** In general RAFE aircraft do not require additional crew members to accomplish their mission. (i.e. Co-pilots, Flight Engineers, loadmasters, jumpmasters, passenger handlers, scanners, etc.). Since most of these are not governed by the FAA, units will design a training program and ensure any ACM has annual documented training.
- **3. Aerobatics** RAFE Pilots will not fly aerobatics in RAFE Aircraft unless they have been evaluated in aerobatics on a RAFE Form 602. Aerobatics below 1500 AGL require a Statement of Aerobatic Competency (FAA /IAC SAC) card.
- **4. Flight Conditions** RAFE aircraft will be flown only in VFR conditions. IFR operations may be approved when aircraft and named pilot are approved by the Director of Operations.
- **5. Flight Restrictions** Passengers are not allowed on:
 - -Pilot training flights
 - -Maintenance test flights
 - -Flights in waivered airspace
- **6. Formation Flying** To fly formation in a RAFE aircraft, the PIC must be either in training, RAFE Formation Rated, FAST or other approved and accredited training rated and current.
- **7. Ground Training** Required prior to flying a RAFE Aircraft and annually thereafter. Ground training must include:
- a. A review of aircraft systems, normal and emergency procedures, an open book test on aircraft systems and limitations and a closed book test on emergency memory items.
- b. A review of RAFE-R 60-1 and an open book test. (HQ provided)

c. If the aircraft is on the RAFE Ride for Hire Program, a review of the

LOA or 6802 exemption (as appropriate) and a closed book test. (HQ provided)

8. Hold Harmless Forms

All persons on RAFE aircraft will sign a Hold Harmless. It is preferable to have the riders spouse or parent sign as the witness. RAFE members will sign a new Hold Harmless each year.

- **9. Instructors/Check pilots** Required to be in a pilot seat when:
- a. An unqualified pilot is flying.
- b. In aircraft requiring two pilots, SIC flies in the left seat.
- c. No person may make a takeoff or landing unless they are qualified or have a transition letter issued by the Director of Operations and is receiving instruction from an IP/CKP.
- 10. Minimum crew Determined by the PIC.

11. RAFE Standard Flight Suits – Required for essential flight crewmembers on all flights

The "Standard RAFE Flight Suit" is the RAFE T-shirt or Polo shirt and other clothing appropriate for the weather.

Essential Flight Crew Positions:

All aircraft: Pilot and/or Co-pilot or Instructor as required. COzyJet X X X Quickie X VariVIggen X X X Varieze X X X Long EZ X X X Defiant X X X Solitaire X

- **12. Passengers** A passenger is a non-required flight crew member.
- a. Four is the maximum number of crew and passengers on an RAFE (Defiant). Two for any two seat aircraft, Long EZ, Varieze, VariViggen. One for single seat. (Quickie, Solitaire)
- b. No Person under the age of 10 may fly in RAFE aircraft.
- c. Passengers less than 18 must have a RAFE Hold Harmless#3 form signed by parent or legal guardian.

Note: A Notarized Minor Hold Harmless is no longer required. It is preferable to have the parent sign the Hold Harmless. Minor Hold Harmless forms must be witnessed by a non-flying RAFE member (not on the flight manifest of the same aircraft the minor will be flying upon). The witness should print their name and then sign.

- d. See Chapter 3 for list of Passenger Restrictions for "Rides for Hire".
- **14. Photo Missions** All Photo missions are considered formation flights.
- a. RAFE Formation requirements must be followed.
- b. Photo missions must be pre-briefed and radio contact must be maintained during flight.
- c. Safety is paramount on photo missions.
- **14. Pilot Currency** -To be current, flight activity is required in the appropriate aircraft group every 180 days.
- a. After 180 days, three takeoffs and landings are required with a pilot current in the airplane to re-establish currency. For Single Seat Airplanes currency must be reestablished in a similar aircraft. (Multi Engine aircraft require a current PIC)
- b. After 365 days, a 602 check ride is required.
- c. Waivers must be submitted by the Operations Officer to the Director of Operations.

B. Pilot Proficiency Flights -required every 12 months.

- 1. Proficiency flights flown with a highly qualified pilot current in the aircraft. These flights should include pre-briefs, air work, pattern work and debriefs. The purpose is to concentrate on being a better pilot in the airplane without any other mission purpose, or distraction. The best Pilot Pros have both pilots flying complete profiles and sharing feedback with each other before and after the flights. In this case, both pilots can sign each other off.
- 2. Document Pilot Proficiency's on the RAFE Form 602 and maintain it locally.

15. Preflight - The PIC will verify all of the passengers/crew have signed a Hold Harmless and are listed on the manifest. Both of these requirements can be met by using one piece of paper, the Hold Harmless and Passenger Manifest "RAFE HH #3 Hold Harmless and Passenger Manifest". The current form is available on the RAFE Members Web site in the Forms and Applications area.

- **16. Purpose of Flight** -- All flights must support the RAFE mission.
- **17. Overwater flights** Aircraft must remain within gliding distance of land.

C. Vice President of Safety, Maintenance and Operations Authority (VP-SMOA)

The RAFE VP of Operations, Safety and Maintenance can approve (in unusual circumstances):

- 1. Non-RAFE pilots for operation of RAFE aircraft.
- 2. Authorize RAFE pilot operations as necessary outside normal procedures.
- 3. Waive the requirements of RAFE-R 60-1

Chapter 2 Aircrew Qualification

A. FLIGHT EVALUATION BOARDS

- **1. Purpose** The Flight Evaluation Board (FEB) is a body responsible for selecting pilot applicants and performing pilot "Fit to Fly" evaluations.
- a. FEB meetings for new pilots/ratings are open for unit members who want to observe.
- b. FEB meetings for "Fit to Fly" evaluations are not open to the general membership.

2. FEB Composition

- a. Flight Evaluation Board Chief (Unit Operations Officer or other Officer and/or one BOD member
- b. Unit Leader
- c. Aircraft Pilot Sponsors as available
- NOTE 1: A quorum is at least three or a simple majority
- NOTE 2: For Sponsor Groups, HQ will appoint the FEB for Fit-To-Fly Evaluations

3. FEB Procedures

a. The FEB process for new pilots/ratings:

- (1.) Does the pilot meet minimum RAFE and FAA requirements?
- (2.) Does the pilot fit the unit needs?
- (3.) Submit the pilot package to RAFE Operations
- RAFE form 600 completed by FEB, not the pilot
- RAFE form 601 completed by the pilot
- Copies of FAA certificates, medical and latest BFR
- Copies of hold harmless and 'What it means to be a pilot sponsor letter"

NOTE: Only the 600 and 601 are required for additional ratings.

RAFE Operations will issue a transition letter to authorize training after reviewing the pilot package.

b. The FEB process for Fit-To-Fly Evaluations:

When a report of substandard or inappropriate pilot performance needs examination, the FEB will convene in person and the pilot will appear before the board in person. Exceptions must be approved by HQ.

Directions:

- 1. Conduct a fact-finding investigation which must include a statement by the pilot
- 2. Determine if any violations of FARs, or RAFE-Rs occurred
- 3. Determine if the pilot's performance was unsafe
- 4. Decide if the pilot should be allowed to continue as a pilot in the unit
- 5. Recommend corrective action/training if appropriate
- 6. Brief the RAFE BOD Unit Staff and include their comments with the Board Report
- 7. Send the report to RAFE Operations

RAFE Operations review the unit report. Their recommendations and those from the unit will be considered in deciding if the pilot will be continued as a RAFE pilot and direct corrective actions as necessary.

B. FLIGHT TIME REQUIREMENTS

1. The following table defines the **minimum** requirements to receive a RAFE pilot rating; tail wheel experience is not required for tricycle airplanes. For tailwheel aircraft, pilot must have 10 hours and 10 landing in a tail wheel aircraft in the last 12 months

200 hrs PIC, retractable and Eze checkout.
200 hrs PIC retractable and Eze checkout.

Quickie 200 hrs and Q type checkout.

Solitaire As required.

The BOD/Director of Operations will designate the check pilots.

C. PILOT TRAINING AND CHECKOUT PROCEDURES

The Commercial Pilot Practical Test Standards are the guide for RAFE pilot training and evaluations.

1. Ground Training/Oral Evaluations

In addition to reviews of aircraft systems and normal/emergency operations, the following subjects must be emphasized in initial/annual ground training test and the oral evaluations conducted with check rides:

Emergency action memory items RAFE-R 60-1

2. Flight Training/Check Rides

- a. The RAFE Form 602 summarizes the PTS and may be used as a guide for profile planning. The RAFE Form 602 will be used to document RAFE check rides.
- b. Document check rides required by Exemptions and LOAs on the prescribed form.
- c. Documentation of check rides required by the FAA satisfies RAFE requirements.
- d. Forward all check ride documents to RAFE Operations. Pilot rating letters and authorizations to operate under the exemptions and LOAs will be will sent to the unit Operations Officer and the pilot.

D. PILOT RATINGS/QUALIFICATIONS

Pilot ratings are type specific.

1. Instructor/Check Pilot

Be a current CFI with FAA and RAFE ratings appropriate for the aircraft; unit request for check pilot ratings will be reviewed by the Operations and Stan Eval committee. The number of check pilots at one location in the same aircraft will be limited.

3. PIC, Multi-engine Defiant

Authorizes the pilot to fly Defiant and any other multi-formation in multi-engine aircraft; a current RAFE Formation card and formation check ride is required.

4. PIC/Flight Lead, Single-engine (LE, VE, VV, Q, S)

Authorizes the pilot to exercise a Statement of Aerobatic Competency; a check ride is required after approval of the Stan Eval Committee. Authorizes pilots to fly in air shows; **Note:** this is aircraft specific.

5. Co-Pilot

Though not required can be unit designated as needed.

8. Rutan Aircraft Flying Experience Formation Qualified (FAST-ER) - TBA

- a. This qualification is a current RAFE member with a valid FAST-ER card. Allows for formation flight in waivered airspace and non-waivered. FAST-ER determines instructor and check pilot requirements.
- b. Credentials awarded by other FAST organizations can be converted to FAST-ER cards by coordinating a check flight with a FAST-ER Lead Instructor.

9. RAFE Formation Unit Qualified

- a. This rating will allow for formation in RAFE aircraft in non---waivered airspace. It also allows for RAFE members flying non-RAFE owned aircraft of similar type, to fly formation with RAFE aircraft. An approved example being a member owned LongEZ flown by a FAST-ER qualified RAFE Pilot can fly formation with other RAFE owned aircraft. This rating will be issued for either a two-ship flight only or for a four-ship or larger formation and will use FAST-ER criteria.
- b. The intent of this qualification is to allow for practice before a FAST-ER clinic or for units activities that do not require waivered airspace.
- c. This qualification may be given by a current or former FAST lead or a pilot approved by the Director of Operations.
- d. All training will be documented on FAST-ER formation forms.
- e. The Unit Operations Officer will maintain these forms and they are subject to audit. Operation Officers are responsible for verifying the currency of all participating pilots and aircraft.
- f. This is a unit level rating; however, RAFE Operations must be notified when it is issued. Email the form 602 to Ryszard Zadow, wallercoaveExperience@hotmail.com anytime a new pilot is added or upgraded.
- g. This is a calendar year qualification. Each pilot must be reviewed each year.

Chapter 3 CARRYING OF PASSENGERS FOR COMPENSATION

A. GENERAL

1. For the present Rutan Aircraft Flying Experience aircraft may NOT be used to fly passengers for compensation or hire. Work towards a 6802 Exemption may provide this in the future and sponsors will be kept advised of any changes.

C. Aircraft Experimental Airworthiness Certificates

- **1**. The operations under a 6802 Exemption are referred to as "Living History Flight Experiences (LHFE)" and the aircraft are authorized by N number.
- 2. At this time there are NO RAFE AIRCRAFT THAT QUALIFY.

1. MAINTENANCE:

(a) Copies of log book entries documenting maintenance will be emailed, or
faxed to the Director of Maintenance and Quality Control
(b) These will be reviewed for compliance with the appropriate subparagraph
of Part 01 400 and filed in the circust files; recogning ingrection dates will

- (b) These will be reviewed for compliance with the appropriate subparagraphs of Part 91.409 and filed in the aircraft files; recurring inspection dates will be entered into the RAFE Aircraft Data Base.
- (c.) Aircraft will be inspected no less than every 24 months by a credentialed maintenance technician not involved with day to day maintenance of the airplane. The cost of these inspections will be paid by the Units where the aircraft are assigned.
- (d) Documentation of these inspections will be filed in the aircraft files. The Follow up to track corrective action on squawks will be documented by the Director of Maintenance and Quality Control monthly and filed in the aircraft files when complete.
- (e) The annual inspection schedule will be published and sent to the appropriate units NLT 31 December.

(2.) OPERATIONS:

- (a.) Pilot Qualifications
- (1) A RAFE form 601 must be on file at Headquarters for every pilot and must include sufficient information to document the pilot meets the threshold experience required by the exemption.
- (2) Every pilot must have a copy of their FAA certificates on file at Headquarters to document they have the credentials required by the exemption.
- (3) Every pilot must have a copy of a current medical on file at Headquarters.
- (b) Qualification and recurrent training programs (Ground and Flight)
- (1) These programs are based on standardized forms provided by Headquarters which include every element required in the exemption.
- (2) The Units are required to fill in the appropriate Unit/aircraft identification information and references for each subject area

from the operating manual/publications used for their airplane. Rutan Aircraft Flying Experience Flight Operations

- (3) The completed forms will be sent to the Vice President of Safety, Maintenance and Operations for approval. Once approved, the plans are the basis for development of instructor notes/guides used when the training is given. The instructor notes/guides are personal tools and do not need to be maintained on file.
- (4) The exemption requires substantial documentation of the training, testing and check rides. The training plans include "fill in the blank" spaces for all of the required information, including the pilot signatures. It is recommended each pilot fill out the appropriate training plan at the completion of every training session and check ride. Documentation may be done in other ways; however, alternate forms used to document training must be approved before uses to ensure elements required by the exemption are included. History has shown when alternate forms of documentation are used, they are frequently incomplete.

SAMPLE LETTER

TO: Prospective Pilots

SUBJECT: WHAT IT MEANS TO BE A FLYING SPONSOR/PILOT

You are about to become a Flying Sponsor of a RAFE aircraft, and if qualified by your FEB, RAFE Headquarters, and the proper RAFE Check Pilot, you may become a RAFE pilot. The requirements for sponsoring a RAFE aircraft are listed in Chapter 2 of the RAFE 60-1 Manual. It is your personal responsibility to read and understand these requirements before you become qualified as a RAFE pilot. Sponsorship donations are a one-time gift for a specific aircraft and are not transferable to another aircraft account or refundable to you. Sponsorship donations are tax exempt to the extent allowed by law. Your donation indicates your interest in seeing a specific aircraft preserved in flying condition and, perhaps, your interest in playing an active role in its operation. Please be aware that your sponsorship donation does not establish a contract, either written or implied, between you and the RAFE that entitles you to be a RAFE pilot. Any Flying Sponsor may make additional donations to an aircraft at any time and as often as he wishes. However, to continue to participate as an active pilot of an aircraft, Flying Sponsors must continue to share in the support of the aircraft. In some instances, you may incur additional costs. Your responsibilities as a RAFE pilot include participating in activities that support the aircraft. You are expected to provide assistance and expertise to unit/group fund-raising events. scheduled and unscheduled maintenance on the aircraft and other such events designed to support the airplane. You are expected to represent the RAFE in a professional manner at all times. You must remember that as a RAFE pilot, you have a unique opportunity to be a goodwill ambassador for our organization. If you choose to no longer be an active sponsor, you can revert to inactive status. If you do so, you will continue to be listed as a sponsor but your flying privileges will likely be removed. You must discuss such eventualities with the unit or sponsor group to be sure you fully understand the ramifications of your decision. You must also know and understand the limits of the RAFE's insurance coverage and the limits of the non-owned insurance you are required to have to fly RAFE aircraft. It goes without saying, you must operate the aircraft in accordance with all RAFE regulations and manuals. I am sure you recognize that the RAFE must have regulations that govern the use of the rare airplanes we fly. It is easy for those of us who are fortunate enough to be RAFE pilots to get acquainted with these requirements and to observe them. We welcome you into the ranks of RAFE pilots and Flying Sponsors. The organization and the airplane need your time, talent, dedication, and continuing support. You are joining a group of dedicated volunteers who are also dedicated pilots. Please contact your Unit Staff, Aircraft Coordinator or RAFE Headquarters Staff if you have questions regarding the sponsorship program.
