**ACQUISITION OF 45% OF THE EQUITY INTEREST IN CHINA SATELLITE MOBILE
COMMUNICATIONS GROUP LIMITED BY ARMARDA GROUP LIMITED**

The Board refers to the announcements dated 29 March 2011, 29 September 2011, 2 December 2011, 3 January 2012, 28 February 2012, 21 March 2012 and 18 May 2012, 11 July 2012, 23 July 2012, 27 August 2012, 16 September 2012, 26 September 2012, 31 October 2012, 2 November 2012, 16 November 2012, 27 November 2012, 18 December 2012, 26 February 2013, 21 March 2013, 31 March 2013, 22 April 2013, 5 May 2013, 27 May 2013, 15 July 2013, 24 July 2013, 15 August 2013, 6 October 2013 and 29 October 2013 (collectively the “**Announcements**”) and the circulars dated 5 December 2011 and 31 October 2012 (collectively the “**Circulars**”) relating to the acquisition of 45% (“**Acquisition**”) of the equity interest in China Satellite Mobile Communications Group Limited (“**CSMCG**” or “**the Group**”) by the Company.

Unless otherwise specified herein or where the context otherwise requires, capitalised terms used in this announcement shall have the same meaning as used in the Circulars and the Announcements as the case may be.

The Directors understand from the press release being made by China Mobile Satellite Communications Group Limited (“**CMSCG**”) (the wholly owned subsidiary of CSMCG) dated 4 November 2013 that CMSCG has received its largest mobile satellite handset order to date with a single order of 5,000 Thuraya mobile satellite handsets from China PTAC E-commerce Technology Co., Ltd. (“**PTAC E-commerce**”), a subsidiary of China National Postal and Telecommunications Appliances Corp which operates in the telecommunication and electronic product distribution, logistics, retail, e-commerce and product repair and maintenance telecom chain. The 5,000 units of mobile satellite handsets will be delivered to PTAC E-commerce before 31 March 2014 and it is expected to be fully deployed with “1349” prepaid SIM cards to users in China before 31 March 2014.

Barring from unforeseen circumstances, it is expected to have positive financial impact to the Group’s EPS and NTA per Share for the financial year ending 31 March 2014.
