What is ATF

These are trading robots that perform transactions automatically in the stock and derivatives markets of the US and Russia, currency pairs,

cryptoassets.
When you purchase ATF token you buy access right of our robots to trade on your capital and

provide additional services using robots.

Our robots already bring profit to our clients, therefore your participation in our ITO is the support of the current business with the potential for growth of turnover in trade with our robots of USD 40 million in 2018, USD 200 million in 2019, USD 400 million in 2020, and the goal to make turnover of USD 1 billion in 2021.

Basic parameters of robots:

1. More than 80 tools are available to trade with

robots at the moment.

2. At the date of this document preparation, our robots brought revenue to our clients on average of 2.4% in US dollars from their capital per month.

3. Each robot has a strict risk control for the position and multi-level client capital management

4. Trading algorithms and capital management algorithms that we have developed for more than 6 years of trading and investment management are our KNOW-HOW and the main asset of our business.

Who will be interested to get ATF token

1. Private investors who do not want to waste their time on trading. They gave money and get profit every month or weekly.

2. Private investors who want to form their own

portfolio to trade with robots.

3. Corporate investors – official registration through our service of Russian legal entities and trading with our robots on your company's free funds are possible.

4. Traders; you can manage our robots, customize them, receive signals from robots, build your

business using our robots.

5. Investment funds, pension funds, hedge funds managers, for which it is important to distribute their portfolios on various profitable instruments and diversify risks.

Development plans of our project

1. Create a global investment fund with a capital of at least USD 40 million. All ATF token owners will be allocated their share in the fund.

2. Create a global broker to enter all world exchanges (reduce our and your commissions for

trading operations)

3. Create our own exchange to trade with cryptoassets (reduce commissions for trading operations from 0.2%-0.5% per transaction to 0.001% per transaction, that will ensure the flow of large investors to the exchange).

4. Create your own closed ecosystem where ATF token will be received in online and offline stores (you as owners are interested in the growth of ATF course, and writing tokens for purchases is one of the guarantors that the number of tokens will decrease with increasing demand for services)

5. We started creating our partner network of agents to promote our services, forming a successful team of traders, negotiates with investment

6. We will transform of all our services on the blockchain in 2018.

The introduction of new services, such as neural networks will increase profits from trading with robots.

Why our robots are reliable

1. Each robot has a loss limit on the client's capital (it is set by you before the start of cooperation) and amount of losses for the transaction. Thus, the robot can not lose more than this limit.

2. The technical solutions on which robots are designed are located on the external cloud services of Amazon Web Services and Microsoft Azure. That provides reliability, safety and robustness of the robots and guarantees to the clients that their data, their money means will be reliably protected.

3. If the robot stops to work for some reason, in this case there is a robot-manager that monitors the execution of requests of other robot-

4. In addition to control by the robot-manager, there is an operator that can interfere with the

trading process.

5. The system of capital risk management is built in such a way that even after a series of unprofitable transactions on certain instruments, others will profit. This enables our robots to show their stable dynamics in the growth of profit on the clients capital.

What services can you get when you buy ATF token

1. Access right for our robots to trade with your capital (service is available).

2. Access right to receive trading signals from robots (service is available in semi-automatic mode)

3. If you want to trade with our robots yourself, we will provide a service for setting up the robot's parameters for your trade (service is available in semi-automatic mode).

4. Right to form the portfolios for you for long/medium/short-term investments by robotmanager (service is available in semi-automatic mode)

5. Access right to your personal profile for you in the role of trader or your fund manager to build your business to manage the capital of your clients using our robots (service will be available in the second quarter of 2018).

6. You can use the service of automatic tracking of robots positions by connecting our robot adviser and watching how it brings you profit (service will be available in the second quarter of 2018)

7. Access to the robots built on the basis of a neural network to increase the result of robot trading (service will be available in the third quarter of 2018).

How the profit getting will look with the use of ATF token

1. You choose the services you want to use.

2. You buy ATF tokens to provide access to the services

3. We connect you with services, having conducted you through the all stages carefully.

4. Once the service is activated the correspond-

ing robots will start working.

5. You will see the results of the service and your income in your personal profile at the end of week or month

6. When you want to withdraw income you will withdraw funds (if you are connected to our account) or receive income from the services of our robots on your personal account.

7. At the end of the service period, part of ATF tokens are disposed to ensure the growth of ATF

8. Our client will be able to receive discounts for ATF token on our website and partners network.

Purchase parameters for ATF tokens

At pre-ITO 1 ETH = 400 ATF tokens. At ITO 1 ETH = 320 ATF tokens.

When you purchase token in the amount of 10 ETH the following additional discount from the purchase volume applies to the price effective at the date of token purchase:

When you purchase 10 to 20 ETH the discount will be 4%.

When you purchase 20 to 100 ETH the discount

will be 8%.

• When you purchase 100 to 400 ETH the discount will be 16%. When you purchase more then 400 ETH the

discount will be 32%.

Blockchain usage in our business

All transactions of our robots will be registered in the blockchain, that will further increase the trust of clients to the robots (because nothing can be changed in the blockchain after the transaction is recorded). To increase the trust between our business and clients, we will transform all the transactions of financial flows

into the blockchain. After the transfer of our services to the blockchain, communication between the robots and clients will be conducted directly under the P2P (peer2peer) scheme, that will reduce the commission for intermediaries, accelerate transactions and build a new class of services using our robots.

Legal aspect of ATF token usage

ATF token is an Utility-token. This means that we provide the RIGHT to use our services and solutions after your purchase the tokens. We do not give share in our business, rights to dividends or other financial mechanisms to participate in profits at this stage of our business development. Subsequently, we have a clear intention to create, within the framework of international jurisdiction, our own collective investment fund, which will issue its token and ATF token owners will be able to exchange it for the fund's token, that will allow all the owners of the new token to become legally significant co-owners of an investment private fund. This step will be implemented during 2018.
