## 1. Purpose

- 1.1 This external Data Protection Policy tells customers, regulators and other stakeholders how the organization collects, uses, retains and discloses personal information.
- 1.2 This Policy is intended to educate the data subject and makes the organization accountable for its processing activities.
- 1.3 This Policy serves as the organization's Privacy Statement, Fair Processing Statement and Privacy Policy.

#### 2. Policy

- 2.1 We at Servio Technologies respect the privacy and confidentiality of personal data in our possession or under our control. We have implemented policies and practices to safeguard the collection, use, disclosure, storage and other processing of personal data provided to us.
- 2.2 We will not process personal data unless:
  - 2.2.1 We process it for a lawful purpose directly related to our business activity and the processing is necessary for, or directly related to, that purpose; and
  - 2.2.2 The personal data is adequate but not excessive in relation to that purpose.

## 6. Who We Disclose Personal Data About You To

- 6.1 We disclose or share some of the personal data we have collected about you to the following classes of parties or organizations outside Servio Technologies:
  - 6.1.1 Business Associates & Professional Advisors external advisors, auditors, lawyers
  - 6.1.2 Data Processing and Hosting Companies cloud service providers, database companies, IT/technical support, webhosting companies and other data processing entities
  - 6.1.3 Marketing and Public Relations Organizations marketing and communications agencies, marketing firms, PR companies

# 7. How We Manage the Collection, Use, Disclosure and Storage of Your Personal Data

- 7.1 We may process personal data about you if the processing is necessary:
  - 7.1.1 For the performance of a contract between you and us
  - 7.1.2 For taking steps at your request with a view to entering into a contract
  - 7.1.3 For compliance with any legal obligation to which we are subject (other than an obligation imposed by contract)
  - 7.1.4 To protect your vital interests
  - 7.1.5 For the administration of justice; and
  - 7.1.6 For the exercise of functions conferred on any person or under any law.
- 7.2 Otherwise, we will obtain your consent prior to the collection or processing.

#### 7.3 Obtaining Consent

- 7.3.1 We will not process any sensitive personal data about you unless we get your expressed consent to do so and the processing is necessary for a purpose permitted by law. Please contact us if you would like information about these purposes.
- 7.3.2 Where we obtain consent from you, whether or not the personal data is sensitive personal data, we will tell you whether it is obligatory or voluntary for you to supply the personal data, and where it is obligatory, the consequences for you if you fail to supply the personal data.

## 8. How You Can Limit the Processing of Personal Data About You

#### 8.1 Withdrawal of Consent

8.1.1 If you have given us consent to collect, use, disclose, store and otherwise process personal data about you, you may withdraw that consent at any time. You should give us reasonable advance notice of your withdrawal of consent.

## 8.2 Restricting the Processing of Personal Data

- 8.2.1 You may also give us notice in writing at any time telling us to suspend, withdraw or order the blocking of personal information for a specified purpose or in a specified manner. This may also include removal or destruction of your personal information in our care. Do note that there will be instances where we may not be able to do so because of legal, regulatory or legitimate business reasons, in which case, we will inform you.
- 8.2.2 Your request for the withdrawal of consent or restrict any processing activity can take the form of an email or letter to us, or through the UNSUBSCRIBE feature in an online service. Where relevant, we may need you to provide proof that the personal information are incomplete, outdated, false, unlawfully obtained, used for unauthorized purposes or are no longer necessary for the purposes for which they were collected.
- 8.2.3 We will then notify you of the likely consequences of your withdrawal of consent, e.g. without your personal contact information we may not be able to inform you of future updates or that the quality of our service may be impacted.
- 8.2.4 Please take note that we would comply with your notice within a reasonable time.

### 9. Accessing and Making Correction to Personal Data

- 9.1 You may ask us (in writing) to inform you what personal data we hold and relevant details about what is being processed by us or by a service provider on our behalf for a particular purpose and, if you say that you would like to receive it, to give you a copy of that personal data in an intelligible form and in a form that is easily portable.
- 9.2 You need to ask us separately for such access to personal data that we hold for each different purpose. We may charge you a reasonable fee for each access request you make to us if there is a cost involved.
- 9.3 We will respond to your request for access to personal data about you within a reasonable time framework after we receive the request from you. If we are not able to do so fully within that period, we will let you know the reasons, comply with the access request to the extent that we are able to do so and comply with it fully as soon as we are able to, after we receive the request from you.
- 9.4 When you make such a request, we may need to verify your identity for example, by checking your valid ID or other legal identification document.

## 10. Accuracy of Your Personal Data

- 10.1 We will take reasonable steps to ensure that the personal data we collect about you is accurate, complete, not misleading and kept up-to-date by having regard to the purpose, including any indirectly related purpose, for which we collect the personal data and further process it.
- 10.2 You may ask us to correct personal data about you where the personal data is inaccurate, incomplete, misleading or not up-to-date. Where we are satisfied that the correction should be made, we will make it within a reasonable time framework from the date we receive your request and give you a copy of the corrected personal data.
- 10.3 From time to time, we may do a verification exercise for you to update us on us on any changes to the personal data we hold about you. If we are in an ongoing relationship with you, it is important that you update us if there are any changes in the personal data we hold about you (such as a change in your address).

#### 11. Protection of Personal Data

- 11.1 We have implemented an Information Security Policy that governs how we protect personal data.
- 11.2 We take practical steps to protect personal data from any loss, misuse, modification, unauthorized or accidental access or disclosure, alteration or destruction having regard to the nature of the personal data and the harm that would result from any such thing happening, the place or location where we store the personal data, any security measures incorporated into any equipment in which the personal data is stored, to the measures taken for ensuring the reliability, integrity and competence of the personnel having access to the personal data and to the measures taken for ensuring the secure transfer of the personal data.
- 11.3 Entities that provide services to us to process personal data on our behalf will be bound by contracts with us that require them to provide sufficient guarantees in respect of the technical and organizational security measures governing the processing to be carried out and to take reasonable steps to ensure compliance with those measures.

### 12. Retention of Personal Data

12.1 We have a Document Retention Policy that spells out how long when we must cease to retain personal data and that requires documents and personal data to be destroyed (paper documents) or deleted (electronic documents and data stored in databases) securely. Certain retention periods are based on statutory or regulatory requirements.

#### 13. Transfer of Personal Data

- 13.1 If there is a need for us to transfer personal data about you to a place outside the Philippines we ensure that the recipient will be obliged to provide a standard of protection to such transferred data that is comparable to the protection it receives under the Philippines law.
- 13.2 Otherwise, we are allowed to transfer personal data about you in various circumstances permitted by law (for example, for the purpose of a contract between you and us or in an emergency concerning you). If you would like more information about these circumstances, please let us know.

#### 14. Location Information

14.1 Note that if you give us the permission to do so via your mobile device, we may use and store information about your location. We use this information to provide features of our Service in order to improve and customize our Service. You can enable or disable location services when you use our Service at anytime, through your mobile device settings.

## 15. Tracking of User Activity

- 15.1 Where we track user activity, we will document this in our Data Inventory, and disclose such activity in our Privacy Notice.
- 15.2 We use tracking tools such as Google Analytics.
  - 15.2.1 **Cookies**. We use "cookies" to collect information about your activity on our web site. Cookies are files with a small amount of data, which may include an anonymous unique identier. Cookies are sent to your browser from a web site and stored on your computer's hard drive. You can instruct your browser to refuse all cookies or to indicate them when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our web site.
- 15.3 We serve ads on our website with Google AdSense
  - 15.3.1 **DoubleClick Cookies**. Google, as a third party vendor, uses cookies to serve ads on our website. Google's use of the DoubleClick cookie enables it and its partners to serve ads to our users based on their visit to our web site or other web sites on the Internet. You can opt out of the use of the DoubleClick Cookie for interest-based advertising by visiting the Google Ads Settings web page.

## 16. Behavioural Re-marketing

- 16.1 We use remarketing services to advertise on third party web sites to you after you have visited our website, we, and our third party vendors, use cookies to inform, optimize and serve ads based on your past visits to our website.
  - 16.1.1 Remarketing and behavioral targeting Google Analytics for display advertising
  - 16.1.2 Website Remarketing tools (e.g. Google AdWords, Perfect Audience, AdRoll, AdNexus)
  - 16.1.3 Remarketing tools (e.g. Google AdWords, Perfect Audience, AdRoll, AppNexus)
- 16.2 You can opt out of these re-marketing services by visiting the website of the relevant third party vendor/s.

#### 17. Compliance With Laws

17.1 Where required to do so by law, we will disclose personal data about you to the relevant authorities or to law enforcement agencies.

#### 18. Links to Other Sites

18.1 Our website may contain links to other websites that are not operated by us. If you click on a third party link, you will be directed to that third party's website. It is important that you review the Privacy Policy of every site you visit. We have no control over, and are unable to assume any responsibility for, the content, privacy policies or practices of any third party sites or services.

- 19.1 We may update our Data Protection Policy from time to time. We will notify you of any changes by posting the policy on this page. Please revisit this page periodically for any changes. Changes to this Policy are effective when they are posted on this page.
