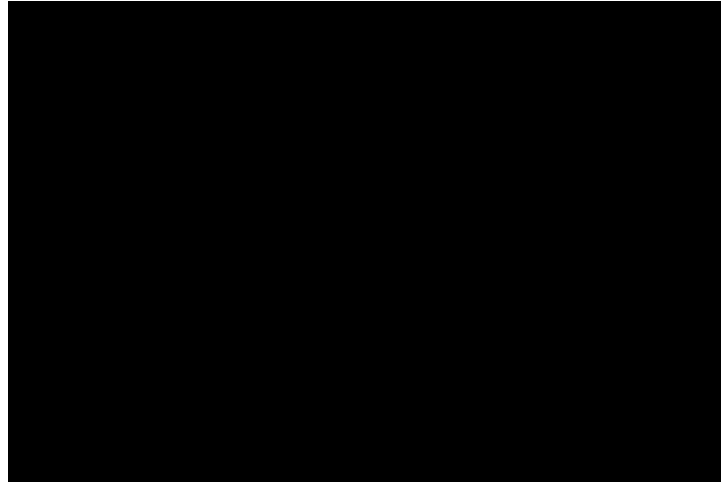

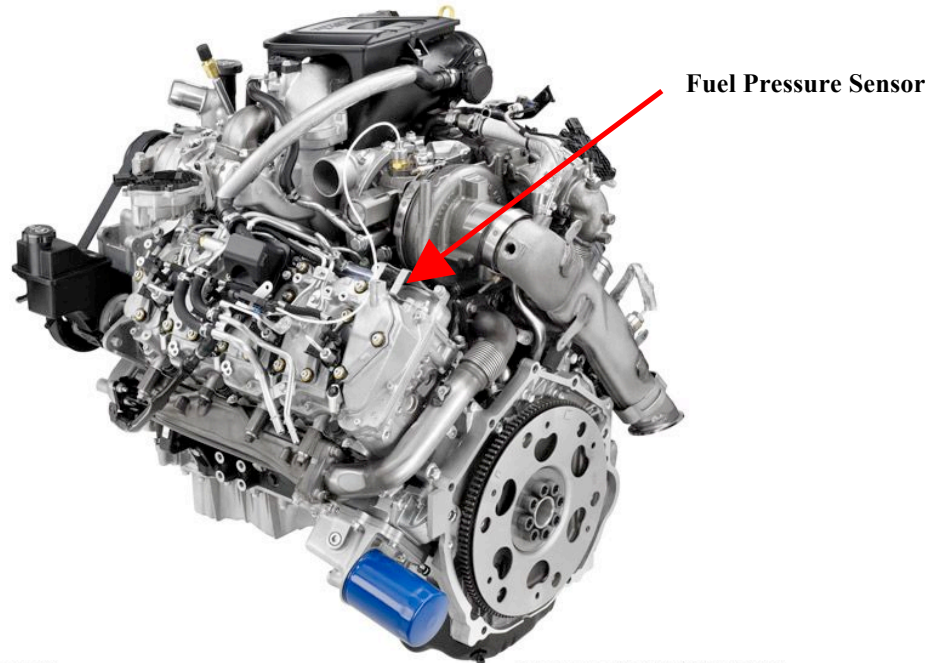

Installation of TS Performance Power Play MP-8 6.6 Duramax LML

Read all instructions and fully understand them before installing your TS Performance MP-8 module. Disconnect battery terminals and remove keys from the ignition before installation. Place Di-Electric Grease onto every electrical connection.



Chevrolet Silverado HD

2011 Duramax Diesel 6.6L V-8 Turbo (LML)

1. Locate the Fuel Sensor. On the LML engine the Fuel Pressure Sensor is located on the back of the fuel rail on the driver's side. The Fuel Pressure sensor is illustrated in the diagram above and the connector will look the same as the one we supply on our harness. Disconnect the factory harness from the sensor by pressing on the back of the tab and pulling the connector toward the firewall.
2. Connect our harness to the Fuel Pressure sensor and to the factory connector.
3. Find a dry location to mount the MP-8 module using the supplied Velcro strip. We recommend a flat surface away from moving parts and extreme heat.
4. Route the wire harness from the fuel pressure sensor to the MP-8 and connect the white 14 pin Molex connector into the MP-8 board.
