## Overview

No incidents have been reported during this period.

Ships Masters/CSO's are invited to report to MDAT GoG, any incident or suspicious activity.

Masters and CSO's are reminded that scamming emails and phishing remain a threat in the GoG maritime area.

The MTISC-GOG completed its operations 20 Jun 16, and its former role and responsibilities were transferred to the UK – Fr activity known as **MDAT-GOG**. The exact details are contained in UKHO Chart Q6114, 30 June 2016. Companies, and Masters are encouraged to report their vessels when transiting the revised Vessel Registration Area (VRA), also described on Q6114 dated June 30 with the MDAT-GOG, using the email address [watchkeepers@mdat-gog.org](mailto:watchkeepers@mdat-gog.org)
