Letter of Appeal on Behalf of XiYue Wang Imprisoned Graduate Student in Iran

Endangered Scholars Worldwide is compelled to express its outrage at the arrest and conviction of XiYue Wang, a 37-year-old United States citizen of Chinese descent, who has been detained since August 2016 by the Islamic Republic of Iran on accusation of "archiving thousands of Iranian documents and having connections to American intelligence agencies." He was sentenced to 10 years in prison while researching Iran's Qajar dynasty for his Princeton University PhD. In the past two years, his wife, Qu Hua has repeatedly stated that her husband has attempted suicide during his time in prison.

XiYue Wang, a US citizen and doctoral student in Princeton's history department, was visiting Iran in 2016 to attend a Farsi language program and perform research for his dissertation. Since August 7, 2016, Wang has been held in Evin prison in Tehran. According to multiple sources, Wang has been mistreated and his health is deteriorating.

On August 29, 2018, the United Nations Working Group on Arbitrary Detention determined that the government of Iran had "no legal basis for the arrest and detention" of XiYue Wang, and that he should be released "immediately."

We at Endangered Scholars Worldwide consider XiYue Wang's detention a flagrant and unjust violation of the freedom, security, and safety of a student who has been caught up in the political tension between the US and Iran—arrested without cause, held for weeks in solitary confinement and without access to a lawyer, and subjected to physical mistreatment and psychological abuse.

Endangered Scholars Worldwide strongly deplores and condemns the ongoing detention, persecution, and conviction of XiYue Wang, and calls upon all international organizations, academic and professional associations, and other groups and individuals devoted to the promotion and defense of human rights to strongly protest and condemn this arbitrary incarceration, to call for his immediate and unconditional release, and to urge the officials of the Iranian government to respect, guarantee, and implement the provisions and principles of human rights as specified in international conventions and treaties in accordance with Iran's obligations under international law.
