SECURITY & PROCEDURES WAIVER

IMPORTANT: Security & Procedures Waiver must be signed and returned prior to entry by all non-Ford attendees on or before **February 16, 2018**.

The Ford Product Development Center (PDC) is a secured area. Attendees are required to check-in at the Welcome desk upon arrival. Attendees must wear the expo name badge at all times. All name badges and plastic cases must be returned when exiting the final day of the expo. (You may keep your badge overnight if you plan to attend day two of the expo.) Your attendance must be contained to the PDC showroom, showroom lobby, and parking areas only. Wandering outside of these approved areas will result in your immediate removal from the building and Ford property.

Photography and/or videography is not allowed in the PDC, PDC showroom, or the courtyard. Any violation will result in the confiscation of your cell phone and/or camera, and you will be asked to immediately leave the Expo and Ford property.

WiFi is provided for texting and checking emails in the showroom and lobby, however, all lengthy phone calls must be done outside of the building.

Exhibitors may not deliver, set up, dismantle or remove booths from the PDC. Also, any and all items larger than hand carry by one person, including all booths, must be delivered to and from the PDC by Show Ready Technologies (SRT). Under no circumstances may anyone other than SRT or PDC Crew remove booths or large items from the PDC.

Ford Motor Company and Show Ready Technologies, Inc. assumes no responsibility for lost, stolen or misplaced items. All valuables, personal items, confidential or proprietary items and materials are the sole responsibility of the exhibitor, owner, or attendee. Such items, properties, and materials should not be left at Ford, or in the showroom, unattended and should be removed after expo hours and overnight.
