

## North Queensland Football "WIN A HONDA JAZZ" Terms and Conditions of Entry

### General

1. Information on how to enter and prizes form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

### Who can enter

3. Subject to the clauses below, entry is open to any registered and financial member of a North Queensland Football zone club, registered between 3 January 2019 and 30 June 2019. Clubs are detailed as Brothers, Burdekin Juniors, Burdekin Seniors, Estates, Goldfields, Ingham, MA Olympic, Northern Beaches, Rebels, Ross River Seniors, Saints, Vikings, Warriors, Wulguru. If the prize winner is under the age of eighteen (18) the car will be registered in the name of the nominating person/parent/carer which appears on the nomination form.

### Open, Close, Selection and Publish dates

8. The competition commences on 3/01/2019 at 9:00 AM and closes at Round 15 (30 June 2019) at 11:59 PM, (the 'Promotional Period').
9. All times noted in these Terms and Conditions are local times, based on the location of the Promoter.
10. The winning entry will be chosen on 26/10/2019, at Brolga Park, William Angliss Drive Annandale QLD 4814 by random selection. The winner will be determined by way of selection (the "Selection") by the Promoter (in their absolute discretion) using a number counter via computer. The Winner must be present to win. If the winner is not there to collect the prize and identified in 2 minutes, the prize will be redrawn every 2 minutes until a winner is found.

11. The judges' decision is final and the Promoter will not enter into correspondence regarding the result.
