| Feb 27, 2018 (Tue)  | SB 234 Inland Port Authority bill officially released during 2018 session. First time draft bill released to public.   | 3 days later    |
| March 1, 2018 (Th)  | First substitute bill SB234S01 (32 pages) replaces original SB234.   | 2 days later    |
| March 2, 2018 (Fri) | Senate Committee hearing at 7 am. First and only public hearing on bill. First time public sees SB234S01 which is recommended by committee at end of mtg.  | 1 day later     |
| March 5, 2018 (Mon) | 8:12 PM Senate submits and passes 2nd substitute bill SB234S02 replacing first substitute bill.  | 3 days later    |
| March 7, 2018 (Wed) | 9:21 PM House replaces 2 <sup>nd</sup> substitute bill with 4 <sup>th</sup> substitute bill SB23404. (29 pages) Where is 3 <sup>rd</sup> Substitute?   | 2 days later    |
