Dates of Competition

The competition commences 1st February 2017 from 12:01am PGT and runs until 11:59pm 31st March 2017 PGT. The major prize winner of the competition will be drawn at 2:00pm (PGT) at BISHOPS head office in Port Moresby by barrel draw. Entrants do not need to be in attendance for the draw. However, entrants and the general public may attend to witness the draw if they wish. The winners will be notified by phone and email. Details of the winners will be published on Bishops website (www.bishopbros.com.pg) from 28th April 2017 and in the Bishops Quarterly Magazine, August – September edition.

Eligibility

The Competition is open to any resident of Papua New Guinea who fulfils the requirements set out in these terms and conditions. Bishops Employees, Bishops Suppliers and their immediate families, are not eligible to enter this competition. Immediate family, which could include but not limited to any of the following: spouse, ex-spouse, defacto spouse, child or step child, parent, step parent, grandparent, step grandparent, brother, sister, step brother, step sister. The promoter has final say on eligibility.

Verification and Disqualification

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these conditions of entry or who tampers with the entry process. The Promoter reserves the right to request the winner to sign a winner's deed of release or any other relevant forms/agreements that the promoter deems necessary, to provide proof of identity. Entry Method & Prizes

To enter, entrants must:

- a. Spend K100 on any product(s) from one of the participating suppliers at any participating Bishops branch in one transaction to go into the draw.
- b. Accept the terms and conditions of this competition.
- c. Fill out and submit an entry form in store.

Entrants may enter multiple times during the promotional period, 1 entry per K100 per transaction. If K200 is spent in one transaction, the entrant will receive two entries. If K199 is spent in one transaction the entrant will receive one entry. The entrant may use a combination of purchases in one transaction from multiple suppliers, e.g. K50 of King Tony product and K50 of Endurite product purchased in the same transaction would earn the entrant one entry. The entrant must fill out their contact details and invoice number on an entry form and submit it in store. If contact details are not filled out completely, the entrant may be disqualified.
