He served in 2002 as senior fellow to US Senator Enzi, Ranking Member on the Senate Foreign Relations Subcommittee on International Operations and Terrorism. The State Department honored his performance with five commendations. adjunct professor and Director of UN Engagement at Seton Hall University's School of Diplomacy. He appears TV news programs as an opinion leader on issues related to multilateral diplomacy. Mr. Dugan served on the board of the Academic Council of the UN System and is a member of UNA-USA Trenton/Princeton Chapter. Biography

Why is the nominee interested in serving as a regional representative? How would they assist members in their region?

I ask you to elect me to continue serving on the National Council because I value building relationships with chapters in my region and I am passionately committed to enhancing UNA-USA's profile among, and resources for, youth and young professional. In my first term, I have built relationships with New Jersey chapters to support their work and promote youth engagement. At the regional level, I would facilitate stronger communication between chapters and, in particular, between community chapters and campuses.

I am passionate about youth engagement because UNA-USA has been formational for me: providing professional and growth opportunities, connecting me to like-minded, passionate peers, and instilling a deeper appreciation for, and familiarity with, the UN. The youth and young professional demographics are a critical, growing component of our national movement, and I want to continue supporting our engagement of this demographic in order to inspire and empower new generations of advocates.

What would be the nominee's greatest contribution to the National Council?

I chair the National Council's Youth Engagement Committee, which proposes national strategies for growing youth and young professional membership, supports chapter-level efforts to promote young leadership, and develops resources for chapters that want to build and expand youth and young professional programming.

In my first term, I led the development of a national network to connect our chapters through their young professional representatives. Our committee has built substantial momentum in the past year: getting more chapters to appoint a young professional representative, identifying common challenges and needs for chapters, building resources and plans to support chapters, and identifying future areas for engagement between the national and community levels.
