Dear Mr. Swabey,

With respect to the application for rezoning by the Vancouver Island Motorsport Circuit, the Municipality of North Cowichan, by letter dated August 18<sup>th</sup>, 2017, requested the following:

"Please ... provide a draft Communication and Public Engagement Plan for review and input by the Municipality prior to finalization. The Municipality has adopted the International Association of Public Participation (IAP2) framework, and it is preferred that this framework be reflected in the Plan. At a minimum, the Plan should include goals, the level(s) of engagement on the IAP2 spectrum, techniques for communication and engagement, a timeline, and a reporting schedule. The reporting schedule should include a commitment to producing a summary shortly after each major engagement initiative or phase, and a final Communication and Public Engagement Summary at the conclusion of the engagement process. All summaries should be provided to the Municipality to inform staff and Council in reviewing the application. The Plan's audience should be both residents of the Municipality broadly, as well as the Sahtlam Neighbourhood Association specifically."

Capturing the above request, I wish to outline our proposed Communication and Public Engagement Plan for review and input by the Municipality prior to finalization:

- 1. Audience
  - Residents, businesses and not-for-profit organizations in the Municipality of North Cowichan
  - Sahtlam Neighbourhood Association

- 2. Goals
  - To inform the Audience on the Vancouver Island Motorsport Circuit's rezoning application and obtain their input and feedback
  - To listen, acknowledge and understand the Audience's views, opinions and concerns and provide feedback on how their input influenced any amendment made to the application
- 3. Level of Engagement on the IAP2 Spectrum
  - Inform
  - Consult
- 4. Techniques for communication and engagement
  - Ensure a two-way flow of information throughout the process
  - Hold two Open Houses at the Vancouver Island Motorsport Circuit initially, followed by a concluding Open House at the Circuit
  - Hold five meetings with the Working Committee at the Circuit
  - Provide written and on-line materials
  - Engage in conversations and face to face meetings
  - Create an e-mail address for the Audience to provide feedback
- 5. Major engagement initiatives for Audience
  - Communicate Engagement Plan
  - Form a Working Committee
  - Compile and provide a written summary after each Phase and a final summary at the conclusion of the process to the Municipality
  - Listen, acknowledge and understand the Audience's perspective
- 6. Timeline and Reporting Schedule
  - Phase 1 April
  - Phase 2 May
  - Phase 3 June
- 7. Conclusion of the Public Engagement Process
  - Final summary July

And further, I wish to propose the following Phases and associated approach:

  - Request the participation of residents and businesses of the Municipality of North Cowichan and the Sahtlam Neighbourhood Association to provide input into the Motorsport Circuit's rezoning application
  - Ads will be placed in the Cowichan Citizen
    - Friday, April 13
    - Friday, April 20
  - Neighbourhood Mail will be distributed by Canada Post to all households and businesses in the Municipality of North Cowichan
    - Week of April 16
  - o Invitation to Cowichan Tribes
- Information available
  - All supporting materials available on Municipality's web site, including:
    - Rezoning application
    - Sound studies
    - Environmental Reports
    - Public Engagement Plan

  - Motorsport Circuit staff
