

Terms and Conditions: Super Mum Competition (October 2018)

Definitions:

Grace Kellie Photography means Grace Kellie Photography Limited (Company Number: 09794822).

Entrant means a person who enters this Competition.

Prize means the free Mini Christmas children's photography Session (RRP £175) on Wednesday 17th October 2018, at 12.30pm, with one child or set of siblings. The also prize includes seven fully edited images, provided on a USB.

Competition means the draw in which a winner of the Prize will be selected.

1. The Competition will run from 9:00am Thursday 4th October 2018 and will close at 11:59pm on Tuesday 9th October 2018. Entries after this time will not be counted.
2. The Competition is run by Grace Kellie Photography.
3. The Competition is open to UK residents aged 16 years or over only. The Competition is not open to employees of Grace Kellie Photography or anyone directly connected to Grace Kellie Photography or this competition.
4. A valid entry into the Competition is:
 - A comment on the specific Instagram post that Grace Kellie Photography posted in relation to the Competition. The comment must include a tagged name (or more than one) of the person(s) they are nominating as the Super Mum. Both the entrant and the person they are nominating must follow the Grace Kellie Photography Instagram account.
5. There is no entry fee and no purchase necessary to enter this Competition.
6. One entry per person will be entered into the Competition.
7. There will be one winner winning a Prize.
8. A winner will be selected by random draw by a representative from Grace Kellie Photography and the winner will be notified by Grace Kellie Photography via Instagram ultimately by 12pm on Wednesday 10th October 2018.

9. A winner will be required to provide an email address to be able to claim their Prize. Confirmation of the prize will be sent to the winner within 24 hours of the winner providing an email address to claim their Prize.

If a winner does not respond and provide Grace Kellie Photography with the required email address before 12pm on Saturday 13th October, then the winner's Prize will be forfeited, and Grace Kellie Photography will be entitled to select another winner in accordance with the process described above.
11. Grace Kellie Photography reserves the right to substitute the Prize for an alternative of equivalent value if this is necessary for reasons beyond its control.
12. The Prize for the winner is non-exchangeable, non-transferable and no cash alternative is offered. The prize is for the one-hour mini Christmas shoot on Wednesday 17th October, at 12.30pm only and cannot be exchanged for an alternative date or time.
13. By entering this Competition the Entrant will be deemed to acknowledge and accept that the information the Entrant provides will become public information and will not be anonymised. Any Entrant may be required to participate in publicity related to the Competition which may include the publication of their name in any media.
14. Personal data supplied during the course of this Competition may be passed on to third party suppliers only insofar as required for fulfilment /delivery/arrangement of the Prize.
15. By entering this Competition the Entrant will be deemed to acknowledge and accept these terms and conditions. Grace Kellie Photography reserves the right to refuse entry, or refuse to award the Prize to anyone in breach of these terms and conditions.
