2. I agree to be supervised by the Animal Control Officer or designee and will work as a team member with all volunteers.
3. If I am unable to fulfill my regularly scheduled hours, I will provide 24 hours advanced notice to the Animal Control Officer or designee.

I assume the risks of being bitten, scratched, injured, or frightened by cats, kittens, dogs, and puppies or any wild animal in connection with my volunteer work for the Mineral Wells Animal Shelter. The City of Mineral Wells is not liable to me for any injuries, damages, liabilities, losses, judgments, costs, or expenses whatsoever that I might suffer sustain in connection with the performance of my volunteer activities for the Mineral Wells Animal Shelter, unless they are the result of the Mineral Wells Animal Shelter's gross negligence or intentional misconduct. I will indemnify, defend, and hold the City of Mineral Wells harmless from and against any claims, lawsuits, injuries, damages, losses, cost, or expense whatsoever sustained by any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for the Mineral Wells Animal Shelter or my breach of the Mineral Wells Animal Shelter's rules. Regulations, policies, and programs.
5. I will treat all animals, other volunteers, and the general public with dignity and respect.
