## Resolution ABTS: 07.16.01

Resolution Supporting the Restoration of Year-Round Federal Pell Grants Sponsors: Rutgers University, University of Iowa, University of Maryland

WHEREAS, a Federal Pell Grant is money from the U.S. Department of Education that is intended to help low-income students afford college, and

WHEREAS, Pell Grants are distributed based on financial need and do not need to be repaid, and

WHEREAS, 8.2 million undergraduate students received a Pell Grant in 2014-2015, and 1

**WHEREAS**, previously Congress allocated funding for year-round Pell Grants, but ended the program in 2011, and

WHEREAS, the maximum award for a Pell Grant is \$5,815 for the 2016-2017 year, and

**WHEREAS,** the maximum award for a Pell Grant will automatically increase to \$5,915 for the 2017-2018 school year, and

**WHEREAS**, the Pell Grant program this year will cost \$22 billion and its surplus this year is projected to be \$7.8 billion, and <sup>2</sup>

WHEREAS, this surplus is the result of slight enrollment declines nationally, tightened eligibility requirements, and improving family finances following the recession, and

WHEREAS, the White House has recommended a return to year-round Pell Grants, and<sup>3</sup>

**WHEREAS,** on June 7, 2016 the U.S. Senate Labor, Health and Human Services, and Education Appropriations subcommittee approved Bill S1062 that would restore year-round Pell Grants with bipartisan support, and <sup>4</sup>

**WHEREAS,** on July 6, 2016 the U.S. House Appropriations Committee released a bill that would prevent the restoration of year-round Pell Grants, and <sup>5</sup>

**WHEREAS**, a return to year-round Pell Grants should provide about 1 million students with enough funds to take summer classes, and <sup>6</sup>

**WHEREAS**, studies have demonstrated that government grants have a positive impact on the graduation rates of low-income students, and <sup>7</sup>

**WHEREAS**, restoring summer Pell Grants can help increase four-year graduation rates and will promote the chances of success for low-income students across the Big Ten, and

**WHEREAS**, the Association of Big Ten Students has a responsibility to consider proposals that work to benefit all of the students who attend Big Ten Universities, and

**THEREFORE, BE IT RESOLVED** that the Association of Big Ten Students supports the restored funding of year-round Pell Grants.

**THEREFORE, BE IT FURTHER RESOLVED** that the Association of Big Ten Students will lobby all respective federal officials and entities to encourage the support of year-round Pell Grants.
