 a. achieves the entry-to-practice competencies set out in the College of Homeopaths of Ontario Entry-to- Practise Competencies document dated January 31, 2012 and
 b. is licensed under the *Private Career Colleges Act, 2005*, or

The applicant **must** have successfully completed:
 1. a prerequisite of Grade 12 Chemistry and Biology, or equivalent and a **Bachelor Degree education or equivalent (including a responsible process for recognizing mature students, however a mature student would have to complete a preparatory science curriculum approved by an accredited Homeopathic Programme prior to commencing their Homeopathic studies) AND**
 2. a program of studies in homeopathy in Ontario that,
 a. achieves the entry-to-practice competencies set out in the College of Homeopaths of Ontario Entry-to- Practice Competencies document dated January 31, 2012 and
 b. is licensed under the *Private Career Colleges Act, 2005*, or

Comparable to other Healthcare Professions like Naturopathy and Chiropractic, this is why the applicant should have a Bachelor Degree. This would also be a huge asset for interdisciplinary care. As the DRAFT REGULATION also states: **“Homeopathy requires a breadth and depth of knowledge, skill and judgment in order to practice safely and professionally.”**

The applicant must complete an approved education program. There will be a prerequisite of at least a Bachelor Degree. The program itself would be equivalent of three years of full-time study and this would include a full clinical experience component provided by the school. The program would achieve the entry-to-practice competencies of the profession.

The program would consist of the following courses:

The Health Sciences are the CORNERSTONE of any healthcare profession. In order to be a successful Homeopath, one needs an extensive knowledge of Health Sciences. In order to communicate interdisciplinary, one needs extensive health sciences. In order to protect the public, one needs extensive health sciences.

These Health Science courses should be taught in a “live” setting by PHDs or Medical Doctors who are specialists in their field. The same should be true for the teachers of Homeopathic Medicine.

For the purpose of this regulation, a maximum of onethird of the required hours can come from clause (b).			
7.(3)	In this regulation, “jurisprudence” means the knowledge of the legal and professional principles that apply to the practice of the profession.
