All horses exhibited will be entirely at the owner's risk. Submitting entry shall constitute acceptance by the owner and exhibitor of all provisions as set forth herein. The above-mentioned entities, as well as members of the Show Committee and their Associates cannot be held liable for loss or injury to the person or property of any visitor, guest or spectator.
