About the Speakers:

Judge J. John Lee was appointed as an Administrative Patent Judge on January 27, 2014. Since joining the Board, Judge Lee has heard appeals from *ex parte* prosecution, appeals from *ex parte* and *inter partes* reexaminations, and presided over trials in proceedings under the America Invents Act, including *inter partes* reviews and covered business method reviews. Prior to his appointment, Judge Lee was a partner at Kirkland & Ellis LLP. Judge Lee also clerked for Chief Judge Paul R. Michel of the Federal Circuit, and worked at the U.S. Attorney's Office for the District of New Jersey. Before entering law, Judge Lee conducted research in the fields of neurochemistry, genetics, and bioinformatics at the Wistar Institute, the University of Pennsylvania, and Brookhaven National Laboratories. Judge Lee received his law degree from the University of Pennsylvania Law School, and also holds bachelor's degrees in bioengineering, biology, and neuroscience from the University of Pennsylvania. He is a member of the bars of the U.S. Supreme Court and the Federal Circuit, as well as Pennsylvania and Washington, D.C.

About the Speakers (cont'd):

Judge Chung K. Pak was appointed as an Administrative Patent Judge of the Patent Trial and Appeal Board (PTAB) on October 1, 1994. Since that time, Judge Pak has worked on Ex parte appeals, reissue appeals, and Ex parte and Inter partes reexamination appeals and served as a member of the PTAB New Judge Training Committee, the PTAB Publication Committee, the BPAI (Board of Patent Appeals and Interferences) Patent Academy Course Review Committee, and the USPTO Diversity Council. He also served as a frequent lecturer to the USPTO's Global Intellectual Property Academy (GIPA) where foreign intellectual property officials and scholars are trained. Prior to this appointment, Judge Pak served as an intellectual property counsel at Praxair, Inc. and Union Carbide Corporation, where he worked on a wide range of intellectual property issues, including domestic and foreign patent procurement, litigation related matters, trade secret, antitrust, and licensing. He also worked as a primary patent examiner at the U.S. Patent and Trademark Office before joining the Union Carbide Corporation. He is a graduate of the Columbus School of Law, The Catholic University of America, and holds a Bachelor of Science degree in Chemical Engineering from Auburn University, Auburn, Alabama. Prior to his graduation from the law school, Judge Pak was an Associate of the Moot Court Board, a Sutherland Cup National Moot Court team member, a winner of the Miller's Cup Intra-School Moot Competition, and a recipient of the Most Outstanding Brief Award for the Miller's Cup Intra-School Moot Competition. He is a member of the Virginia, Maryland, and Washington, D.C. bars.
