The Frankfort Arts Association is working with the Frankfort Chamber of Commerce to exhibit a fine art pop-up gallery in the Trolley Barn during the Frankfort Wine & Ale Walk.

It is not necessary to purchase an event ticket to have artwork featured or to attend the exhibit in the Trolley Barn. However, you will need a ticket if you wish to participate in the Wine & Ale Walk festivities featuring 20 wine stops and 10 appetizer and dessert stops. ## CALL FOR ENTRIES

Artist are invited to submit up to two pieces of artwork. Space is limited. To have your item(s) considered, email entries by **Monday, September 16th**. Send Email to **entries@frankfortarts.org** with the subject line **POP-UP GALLERY**.

Please include: • Your name • Title • Medium of your piece(s) • Size of your piece(s) • Photo of your piece(s) and Price of each piece.

### Eligibility

The exhibit is open to artists over the age of 18. All entries must be the original work of the artist. Applicants are allowed to submit up to 2 entries.

### Entry Specifications

Original art in painting, drawing, mixed media and 3D. Work must be either framed or, if stretched, finished in gallery wrap, labeled and ready to hang.

### Size Limitations

Work must not exceed 40" x 44" including frame and must not exceed 4" in depth

### Entry Fee

There is an entry fee of \$15 to submit up to two pieces of artwork.

### Receipt of Work

Delivered artwork on:

between 9am - 10am  
Trolley Barn  
11 S White Street , Frankfort  
Drop off at the back entrance**

Delivered work MUST reflect Entry Form submissions. Arrangement can be made for early drop off.

### Return of Work

Any unsold artwork may be taken home by artists at the end of the evening (7:00pm) or picked up at the Trolley Barn

**Sept 30, between 9am - 11:00am**

### Sales

The Frankfort Arts Association receives 30% of sale proceeds, with 70% to the artist. Illinois sales tax is applicable. A payment check will be issued within 30 days of the event. All artwork not picked up within 30 days becomes property of the FAA unless prior special arrangements are made.

### Photography Waiver

By emailing your entry you give the Frankfort Art Association (FAA) permission to use images of you or your artwork for the purposes of promotion in connection with the FAA.

### Liability

The FAA shall, upon possession of the artist's work(s), exercise due care in handling. The FAA shall not be responsible for any loss or damage to the artist's artwork while in the FAA's possession.
