While comparing the experience to reasonably expected outcomes, I do acknowledge the fact that the lives lost to violence are precious to their loved ones. Absent the introduction of expertly trained and dedicated police officers, I don't know what more can be done to counter the threat of violent crime.

Community policing on campus and in the community where affiliates come and go in the area surrounding the campus seems to me to be the best solution for a wide range of community safety concerns.

JHU's proposal would create a private police force with some limited training. The training is recommended in the bill, not required. The populations listed for special consideration inadequate; they list fewer than are in the consent decree. This will endanger LGBTQ and undocumented folks. Three police force will be protected by LEOBR, shielding them from disclosure of complaint disposition, if any. Given JHU's failure to adequately oversee Title IX violations, I doubt they will adequately oversee a police force.

JHU could create a Safe Streets site, or multiple sites. Safe Streets (the Chicago model) has been effective in other neighborhoods across the city, is a community-led response to violence that employs formerly incarcerated people, and has significantly reduced crime in catchment areas. Th cost of a Safe Streets site is <\$1 mikkion per police post. This is more cost effective AND more empirically effective than policing.

On the FAQ section of their website, Hopkins appears to address how they will avoid making the same mistakes that other private university police will make (acknowledging a history of racial profiling and poor mediation of incidents with individuals in mental health crisis from institutions Hopkins built their model off of), but then answer the question by saying they will give the same training and have the same accountability mechanisms as those institutions employ. I just can't believe there is any incentive for Hopkins to build in any accountability for officer misconduct since it would require them to acknowledge it in the first place. After all the trouble they went through getting this proposal approved, they would never want to admit their officers did the exact thing the opponents to their proposal said they would do.

Beyond the moral imperative, what does it mean for the neighborhood when the inevitable police brutality event happens? How will it affect home prices and quality of living when Charles Village is plastered on the media everywhere for the time someone got robbed and someone else got shot by police? Will outside agitators then come into Charles Village to heighten the tensions an event like this will bring to the community? Charles Village has a lot to offer Baltimore, its current residents, and future tenants, and I worry we are hitching our wagon to a horse that we know will run into a ditch.

Having interacted closely with JHU's current security implementation, I feel certain that in practice the University's efforts are designed to primarily protect the safety of the university and its affiliates and the general safety of Baltimore secondarily. Which makes sense given they are paying for it, but I do not believe that will greatly improve public safety.

I am alarmed that given the lip service JHU has paid to accountability for the community, only tangible efforts are centered around attending community meetings and the Civilian Review Board. Attending these meetings is good, however, there is not practical accountability that comes from attending if there is no actual oversight or power among community members to reign in any problems that may arise. Instead, community members could only give feedback and the University can realistically just "listen" and then take whatever action they want. When at the January general CVCA meeting the JHU representatives seemed unclear about how they would handle FOIA-type requests, I was deeply concerned as this would be one of the few tangible ways that the community could work to hold a private, essentially corporate police force accountable and they seemed surprised it was mentioned even though the issues with university policing and FOIAs is well known due to its escalation to the Supreme Court of Illinois.

I have deep concerns about the safety and comfort of community members in CV who are already vulnerable to profiling and issues with police (homeless, people with mental illnesses or disabilities, POC, etc.) and adding a police force whose primary concerns would be university safety and could create an even more exclusionary space than the current blanket of security already does.

I'm opposed to an essentially corporate police unit whose primary concern will be to protect its constituents over the needs of the community it is in. I know that the university has tried to say that it's goal will be the general public's safety, but this seems unlikely and disingenuous if it would make such an investment and not focus on its own needs first. If the public safety would be its actual concern, they would be working to fix the troubled PBD rather than creating their own force. This feel very much like JHU's claims with the EBDI that they were operating in the public good when the reality was years of vacancy.

Already the Hopkins patrol efforts make many neighbors, myself included, feel like interlopers in my own neighborhood. I feel like I live in a "police state" with the presence of the university expanding in to the neighborhood making it feel as though we are all under watch. I understand that there are some neighbors who really like the security, but really to me I find it more of a constant reminder that Hopkins would like insulate itself from the community.

I don't think Hopkins is necessarily a "bad neighbor" but I do think that a stronger relationship with Hopkins could be made if many in the surrounding neighborhoods didn't feel as though Hopkins good will and largess didn't come with the cost of living under watch.

If they really were serious about making public safety improvement, the university would invest in the Norther District's efforts to improve policing and invest in a system that will be sustainable, by definition accountable, and public.

Because the JHPD is being modeled after American police departments rather than criminal justice systems in countries that are much less willing to murder, imprison, and enslave their fellow citizens on a regular basis in the name of the law, e.g., Norway, I believe the JHPD will unnecessarily put all members of my community at increased risk of loss of life or permanent injury. Outcomes outside of the US make it abundantly clear that lethally-armed law enforcement officers put everyone in the community - including themselves - at greater risk. Therefore, even if the JHPD poses a relatively lower risk than that of other American police departments, I would vote against it were my community given the opportunity to legally defend itself against the encroachment of the colonial authorities of the Johns Hopkins University.

Furthermore, I expect that the lion's share of both real and perceived increases in safety of person and property will be enjoyed solely by we the non-Black members of these communities, further widening the gap in positive health and safety outcomes between majority-Black and majority-non-Black communities in Baltimore. This seems starkly at odds with the Hippocratic Oath that every physician employed by the Johns Hopkins Hospital system has sworn to uphold, though perhaps by some tortured logic the board empowered to make decisions on their behalf may be absolved on the technicality that a majority of its members have never sworn a similar oath. (As academicians swear no such fealty to their fellow citizens, perhaps they're free of this burden of morality.)

Since the JHPD would replace other professional law enforcement officers, it stands to reason that JHU has determined that the BPD is insufficiently skilled to keep its campuses and employees safe. Due to the fact that JHU is substantially better-funded than the BPD, I would prefer they assist all communities in Baltimore by lobbying for improvements to the BPD at large. It's very clear that the issue papers for the JHPD could improve the efficacy of all police in Baltimore, and it would make more sense to provide a modernized academy for those police than it would to only do so for the police in communities that are already doing best.

If JHU and its trustees have determined that crime is unacceptably high in and around its property - some of the wealthiest, safest neighborhoods in the entire city of Baltimore - doesn't it also stand to reason there are others who could use the help more? For example, what if JHU were targeting increasing the safety of the communities from which career criminals originate and in which they seek asylum? Wouldn't this not only help those in greatest, but also stem the tide of crime occasionally trickling up onto JHU's shores?

In short, while JHU is of course a private institution, I argue it's short-sighted and politically naive to prioritize meeting its own meager needs at a time when its sisters and brothers nearby are in much more dire straits.
