TO: MEMBERS OF MEMBERTOU

TAKE NOTICE that a Ratification Vote shall be held in accordance with the Membertou Community Ratification Process in order to determine if Eligible Voters approve the *Membertou Land Code* and the Individual Agreement.

The following question will be asked of the Eligible Voters of Membertou by ballot:

"Do you approve:

- **The *Membertou Land Code*, dated March 12, 2019; and**
- **The *Individual Agreement with Her Majesty the Queen in Right of Canada?***

Advance Polls for the Ratification Vote will take place on Friday the 7th day of June, 2019 from 9:00 a.m. until 8:00 p.m. at:

Membertou Trade & Convention Centre at 50 Mallard St. Membertou, Province of Nova Scotia.

The Official Voting Day for the Ratification Vote will take place on Saturday the 8th day of June, 2019 from 9:00 a.m. until 8:00 p.m. at:

Membertou Trade & Convention Centre at 50 Mallard St. Membertou, Province of Nova Scotia.

The Electronic Voting Methods will be available from Noon on Saturday the 27th day of April, 2019 to 8 a.m. on Friday the 7th day of June, 2019. Electronic Voting Methods will not be available during regular polls on voting days (Advance Polls and Official Voting Day).


