HANDLING PRECAUTIONS: When mixing or applying, wear protective clothing, gloves and goggles. Do not eat, drink, smoke while using. Wash hands and face, exposed skin before meals and after work. Wash protective clothing after work.
STORAGE: Store in original container tightly closed and in a locked, dry, cool, well ventilated area, away from feed, seeds and foodstuffs. Storage must be generally in accordance with NZS8409 Management of Agrichemicals. See the PRODUCT SAFETY CARD for further information.

**FIRST AID:** If swallowed do **NOT** induce vomiting. For advice, contact the National Poisons Centre **0800 POISON (0800 764 766)** or a doctor immediately. If skin, hair or eye contact occurs, remove contaminated clothing and flush skin, hair and/or eyes with running water for several minutes.

#### PRODUCT INFORMATION

**PEPTOIL** is a superior paraffinic oil with a special blend of surfactants and an added anti-foam designed for use with pesticide sprays. **PEPTOIL** is a general purpose Crop Oil Concentrate with excellent emulsifying properties and will suppress foam development in tank mix combinations to which it is added.

#### DIRECTIONS FOR USE

**NOTE:** Always follow the directions for use as recommended on the pesticide label. **PEPTOIL** is only an adjuvant to supplement the performance of the pesticide it is mixed with. The pesticide label for specific uses and restrictions have precedence over directions for uses contained on this label.

**MIXING:** Pour the required amount of pesticide into the partly filled spray tank with agitation running. Continue filling and add the correct amount of **PEPTOIL**. Continue agitation.

#### RECOMMENDATIONS

**For use with certain fungicides:** (e.g. carbendazim, mancozeb, etc): 0.5 - 1.0 litre hectare to enhance activity and improve spreading. Follow directions on the fungicide label.

**For use with insecticides:** 0.5 - 1.0 litre/ 100 litres of water to improve spread and penetration. Follow the insecticide label recommendations.

**For use with certain herbicides:** Pre-emergent uses of linuron, prometryn, atrazine, diuron, paraquat, etc.: 0.5 - 2.0 litres hectare to enhance contact activity.

With specific selective grass killers e.g. haloxyfop, fluazifop, etc.: 0.5 - 4.0 litres hectare. Follow the directions on the herbicide label.

With specific selective broad - leaf weed killers, e.g. chloridazon: 1.0 - 1.5 litres hectare to enhance knockdown of 2 - 4 leaf emerged weed seedlings. For use with **Monarch™** herbicide. Use 1.0 litres/ha on small weeds and 2 litres/ha on larger weeds with over 6 true leaves.

#### NOTES:

1. Always read the pesticide label before using.
2. **PEPTOIL** increases the activity of pesticides. A test area is recommended whenever :
  - a) spraying an untried pesticide combination not suggested on this label
  - b) spraying new varieties or highly inbred lines
  - c) spraying proven combinations on previously untried crops.
3. Use care during periods when pesticides are more active e.g. very hot or humid conditions.
4. Keep container tightly closed and **DO NOT** allow water to be introduced to contents of this container.

#### COMPATIBILITY:

**DO NOT USE ON ANY ORNAMENTAL CROP INCLUDING THOSE GROWN FOR CUT FLOWERS, FOLIAGE AND NURSERY PLANTS**

Should not be used within 10 - 14 days of captan, chlorthalonil or sulphur sprays. Do not mix with dinocap, lime sulphur or carbaryl.
