Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	DO NOT touch or walk through spilled material. Wear PVC overalls, chemical resistant gloves, boots, facemask or goggles. Prevent further spillage. Small spills : Collect spilled product and place in sealable container for disposal. Spill residues may be cleaned up using water plus detergent. Seek advice from the Local Authority or the SDS or product label regarding disposal. Larger spills : Report large spills to 0800 CHEMCALL (0800 243 622).
