Accident Call the emergency services: Dial 111 Spill or leak Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Adsorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Fire Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. **FIRST AID** If Swallowed DO NOT induce vomiting.
