Check for spills, leaks, Accident Call the emergency services: Dial 111 Spill or leak Wear overalls, chemical resistant gloves, boots and safety goggles. Prevent further spillage. Sweep up solids without generating dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Extinguish fires with dry Fire chemical or CO₂. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off.
