Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

- 1. The promoter of the competition is the St George Illawarra Rugby League Football Club Pty Ltd ABN 74 085 008 340, 124 Princes Hwy Kogarah, NSW, 2217 ('St George Illawarra Dragons').
- 2. Directors, management and employees of the Promoter and their immediate families are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, step-sister or 1st cousin.

- 8. The St George Illawarra Dragons abide by the Privacy Act 1998 at all times. The St George Illawarra Dragons will not misuse or change your information without your knowledge. We will not share your information with anyone who doesn't have authority to see your information.
- 9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 10. One winner will be drawn at the Promoter's premise on Monday 22 January 2018. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be notified by telephone on the day of the draw.
