VOTE FRAUD

The following content is from a VOTE FRAUD PROJECT that was commenced and then abruptly halted, HOWEVER, THERE IS MUCH USEFUL CONTENT.

RESPONSE TO METHODOLOGY REQUEST

Our data previously submitted and ongoing analyses consist of work performed by professionals who are retired from the Intelligence Community, former FBI Agents who have successfully performed on various projects during the Campaign, a world class private investigator who has his own formidable network, investigative journalists and highly capable parties from various disciplines.

All parties have agreed to maintain confidentiality until each interval report is made public.

There are a number of parties focused on vote fraud that are performing their own investigations who have shared their intel beginning as far back as October 2016 and so far most are agreeable to continuing to share their information.

RESPONSE TO EXPOSE VOTER FRAUD OPERATIONS

The following is a brief summary of my perception of the task from oral and written communications, to confirm details of the operation including Mission clarification, the theme of what is to be publicized, who we seek to expose, the proposed process to achieve optimum results and a random sampling of archived aggregate media product examples.

I AM CALLING THE TASK OPERATION TRUTH COUNTS (OTC) FOR BREVITY OF COMMUNICATIONS.

FOR CLARIFICATION I AM DISTINGUISHING BETWEEN VOTE FRAUD THAT DEFINES THE PROCESS AND ENCOMPASSES ALL FORMS OF VOTE FRAUD, AND VOTER FRAUD, THAT REFERS TO INDIVIDUALS WHO VOTE BUT WHO ARE NOT ELIGIBLE.

GOP REQUEST TO EXPOSE VOTE FRAUD TO PUBLICLY DENOUNCE ATTACKS BY LEFT RADICAL PUNDITS

I am summarizing the discussions thus far regarding what the GOP has told us, evidence we have available, the process and what the GOP is requesting in order to better define the purpose of the task and results anticipated.

- Matching County voting records with additional local records
- Cross referencing data from sources besides each County
- Drawing comparisons of votes cast versus voting population per Precinct per County
- Utilizing and vetting media broadcasts, their aggregate media products and evidence shared by alliances
- Interviewing voting officials
- Utilizing First Class U.S. Postal Service return receipt marker as tool to verify voter status
- Interviewing voter machine distributors and their repair personnel
- Engaging recognized accounting firms to perform audits to add to our credibility

RANDOM EXAMPLES OF VOTE FRAUD AND VOTER FRAUD

I randomly pulled some YouTube videos, some of which our group submitted raw data to that we have on file which speak to the issues and provide evidence, however, please do not post until we are 100% sure about EVERY name and the details that are listed on a report.

The process of matching records is actually simple but also time consuming and we need to work through the data at least twice as sometimes there can be common duplicate names, that are different people and any video evidence has to be thoroughly verified including videos that may seem irrefutable, such as videos of events that happened in foreign countries but claim to be the U.S.

DETROIT NEWS REPORT TITLE RECORDS: TOO MANY VOTES IN 37% OF DETROIT'S PRECINCTS

Voting machines in more than one-third of all Detroit precincts registered more votes than they should have during last month's presidential election, according to Wayne County records prepared at the request of The Detroit News.

Detailed reports from the office of Wayne County Clerk Cathy Garrett show optical scanners at 248 of the city's 662 precincts, or 37 percent, tabulated more ballots than the number of voters tallied by workers in the poll books. Voting irregularities in Detroit have spurred plans for an audit by Michigan Secretary of State Ruth Johnson's office, Elections Director Chris Thomas said Monday.

We had insider involvement (legally) in this recount matter and in the Pennsylvania proposed recount and an additional matter in Michigan (pertaining to the Jill Stein initiated recount efforts) so we have first hand evidence.

The three States called out by Libertarian Jill Stein have put both the Democrat establishment and the Republican establishment in the hot seat due to the irregularities immediately identified at the onset of the recount preparation, and accordingly representatives of each Party tried to avoid the recount through various means.

These irregularities and outright fraud seem to exist in at least 26 States (every additional State we investigated so probably the remaining 24 States have issues too) when we started kicking the tires and while the vast majority (90%+) of the fraud was by Democrats some Republican involvement was observed but instead of stacking the deck for President Trump, their offense was looking the other way to allow the Democrat fraud to continue. Perhaps they were simply not attentive or as we witnessed during the campaign, those representatives may have been part of the effort by some Republicans to try to keep President Trump from taking office.

The aforementioned cases are a fraction of the ones we have archived that have some type of news report attached. We have many more that are not yet public but that seemingly will check out. We also are joining forces with various groups conducting their investigations.

Putting a calculator to the evidence at hand for the first 26 States and what the average percentages are, then tallying the widespread voter fraud in California, Virginia, Michigan, Pennsylvania, Illinois and Florida where the percentages from the first precincts reviewed are at a much higher ratio, the numbers possibly exceeding 4.7 million fraudulent votes could easily make President Trump the popular vote winner.

The faster we can re engage our highly capable Veteran and Civilian Investigators while the data is fresh and the offenders and witnesses have recollection, the better for producing a more comprehensive high quality and quantitative report.

GENERAL MECHANISMS USED AND STRATEGIES OF PARTIES COMMITTING FRAUD

We have hundreds of reports like the following that provide starting points for investigations plus our many leads and some insiders who have defected.

According to the [Pew Charitable Trust](#), one in eight voting records in the country is inaccurate, due to bad information, addresses, etc. The 2012 study also found that nearly 2.8 million people are registered in two or more states, and 1.8 million registered voters are deceased.

The Public Interest Legal Foundation reports that making registering to vote easier via the “motor voter” law has resulted in non-citizens and other ineligible people registering and voting in several Virginia counties, thus diluting the votes of eligible citizens.

The Public Interest Legal Foundation published a report based on voting history records in Virginia showing that large numbers of ineligible aliens are registering to vote and casting ballots. They are canceling out the valid votes of American citizens. In Virginia jurisdictions, the number of people registered to vote exceeds the number of citizens eligible to vote just like every State a tally was performed totaling 26 States so far.

Excerpt:

“An investigation in Virginia by the Public Interest Legal Foundation (PILF) and the Virginia Voter’s Alliance (VVA) shows that the cause of this problem is something much worse than simple ineffective governance. Worse still, Virginia state election officials are obstructing access to public records that reveal the extent to which non-citizens are participating in our elections. These obstructionist tactics have led to PILF and VVA obtaining data from only a handful of Virginia counties so far. But the information from a few counties demonstrates a massive problem.

In our small sample of just eight Virginia counties who responded to our public inspection requests, we found 1046 aliens who registered to vote illegally.

The problem is most certainly exponentially worse because we have no data regarding aliens on the registration rolls for the other 125 Virginia localities. Even in this small sample, when the voting history of this small sample of alien registrants is examined, nearly 200 verified ballots were cast before they were removed from the rolls. Each one of them is likely a felony.”

All of these statistics and the actual incidents are trackable utilizing the processes described in this summary.

We will compile all corroborated information into a report including the name of each of the audit companies.
