## Summary of key findings for parents

### This provision is outstanding

- The manager and staff have exceptional knowledge of early years teaching combined with a shared vision for excellence. Children make rapid progress in their learning.
- The outside area has an array of activities to choose from. All the natural resources and materials are thoughtfully arranged with excellent attention to detail.
- Staff engage and highly motivate children with their dedication and enthusiasm for teaching.
- The manager and staff go way beyond expectations to provide a positive learning environment for children. This significantly contributes to children's wellbeing and their love of learning.
- Children's safety and well-being is given the highest priority. Senior staff continuously evaluate all procedures to protect children from potential risk.
- The Pre-school promotes a totally 'child-centred environment'. All children, including those with special educational needs and those who speak English as an additional language, make excellent progress from their starting points.
- Staff form strong partnerships with parents. Parents feel well informed and comment on how the manager and her staff are so helpful, kind and caring and how well their children are learning and developing. One parent described the Pre-school as 'magical'.

## What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

- To further build on the already excellent sharing of information with parents about children's learning at home

- The inspector observed the quality of teaching and the impact this has on children's learning during activities inside and outside
- The inspector talked to parents available on the day of inspection and took account of their views
- The inspector talked to staff at convenient times during the inspection and assessed how well they keep children safe and support children's learning
- The inspector carried out a joint observation with the Pre-school manager

## Inspection findings

### Effectiveness of leadership and management is outstanding

The manager is passionate in her drive for excellence. She leads a team that are highly committed and knowledgeable, with exceptional skills that help enrich children's learning. Meticulous detail is given to planning for every child's unique interests, learning styles and qualities. The manager places high regard to continuous improvement. Staff access a wealth of training and development and constantly reflect on their practice. Safeguarding is effective. Comprehensive risk assessments are in place that help protect children from harm. All staff have exceptional knowledge on how to recognise when children may be at risk.

### Quality of teaching, learning and assessment is outstanding

The quality of teaching is exceptional. Staff have high expectations of what children can achieve. They are highly responsive to children and challenge their learning to the highest level. Staff accurately assess children and monitor their progress. Activities are provided that keep children engaged for significant amounts of time because the activity is so stimulating. Children excitedly use buckets of water and paint brushes and work together collaboratively to decide how they can paint the roof of the playhouse as they cannot reach it. All children thrive in this extremely effective, nurturing environment.

### Personal development, behaviour and welfare are outstanding

Children are confident learners. The fun, homely environment allows every child to quickly feel at ease. Children are extremely insightful and they have responded exceptionally well to a recent topic about the importance of recycling. They develop a thirst for knowledge and confidently explain that we must not allow plastic to get into the sea. All children form strong attachments to their key person and confidently understand rules and boundaries. Children's behaviour is exemplary.

### Outcomes for children are outstanding

Children thoroughly enjoy their learning and make rapid progress from their starting points. Those who need extra help are supported exceptionally well and quickly catch up with their friends. Children develop a wealth of skills which help them become confident and ready to start school. They listen well, communicate clearly, ask questions and show interest and curiosity in everything around them. For example, on the day of inspection, children were fascinated and delighted when they successfully used a flour paste as 'glue' and managed to 'stick' wooden blocks to the brick wall.

Early Birds Pre-School Group registered in 2000. It operates from a church in Seaford, East Sussex. The group opens five days a week during school term times. Sessions are from 8.30 to 3.00pm Monday, Tuesday and Wednesday. 9-12noon Thursday and Friday. The pre-school receives funding to provide free early education for children aged two, three and four years. There are 5 contracted members of staff with 4 of those holding qualifications at level 3 or above.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
